**BILL NO.** HB83

**Analysis**

HB83 would change the obligation of attorneys and parties who settle certain civil litigation cases. The parties and attorneys will report their settlement information only when requested to do so by the Alaska Judicial Council. Because the Council is currently funded to collect this information, no funding is necessary.
