#### **Mission Statement**


Alaska Court System





#### Criminal Jury Trials FY12 – FY14

- District Court Misdemeanor Trials for FY14 are up 13% from FY12 Trial Totals and up 28% from FY13 Trial Totals








#### FY16 Operating Budget Increments

- Facility Operations and Maintenance Expenses - \$179.2
- Jury Trial Expenses \$275.0
- Security Screening \$320.0
- Computer Replacements \$100.0
- Data Exchanges with Department of Corrections - \$150.0



#### FY16 Operating Budget

- Annual Budget Development Process Commences in August
- FY16 Budget Approved by Supreme Court in October 2014 - Prior to the Severe Decline in Oil Prices
- FY16 Operating Budget Increment Requests Withdrawn and Base Budget Reduced
