FISCAL NOTE ANALYSIS

Analysis

This Bill creates a king salmon tag program , making stamps available for the creation of king salmon limited edition prints and provide for the sale of stamps and prints to the public.

This analysis takes into account all foreseen costs to coordinate a new program including staff time, artist contracting, printing, and shipping costs. We anticipate printing 500 limited edition prints the first year and 1,000 each year after that.

Personnel costs cover salary for a portion of a position (Range 18) to lead and coordinate the program including developing and administering artist and printing contracts. This position is expected to work 4 months the first year (\$28,000) and 2 months in subsequent years (\$14,000) on this program. The department anticipates adding months to an existing seasonal position. Personnel costs also include staff time spent on sales and distribution of stamps and prints; these costs are estimated at \$1,800 for 500 prints, and \$3,600 for 1,000 prints.

Costs for services include:

- contract with artist: \$2,500 - \$5,000 per year
- printing contract for prints: \$8,000 (500 prints) - \$16,000 (1,000 prints)
- mailing supplies/postage: \$4,000 (500 prints) - \$8,000 (1,000 prints)
- increased cost for stamps: \$1,800

Sale of prints would generate an unknown level of revenue. Based on other similar prints, we expect a price in the range of \$100/print. If all prints are sold, revenue could reach \$50,000 for 500 prints and \$100,000 for 1,000 prints. However, actual demand for prints is unknown and we assume sales at 100 prints the first year, growing to 500 prints by year five. Revenues generated by similar art print and stamp programs developed by states (including State of Alaska duck stamps) in the 1980s experienced high initial sales and revenues the first year followed by steady annual declines.
