FISCAL NOTE ANALYSIS

STATE OF ALASKA
2016 LEGISLATIVE SESSION**Analysis**

This bill improves consistency in the application of barring conditions for all individuals in direct contact with vulnerable individuals. Currently, the statutes provide that only certain position types are barred for certain offenses; the same standards are not applied to all applicants. The department is finding that applicants are manipulating this loophole in the application process, and the statutes have exposed vulnerable Alaskans to individuals intended to be barred from contact.

It also allows individuals to submit a background check, personally, without associating with an employer first, which should expedite the employment process for providers and ensure workforce stability for facilities and individuals caring for vulnerable individuals. This bill clarifies what type of civil findings would constitute a bar, such as those that have been subject to due process through an administrative hearing.

This legislation also allows the department to investigate an employee, contractor, or volunteer of a licensed entity and, if a substantiated finding of non-compliant conduct is established, place the employee, contractor, or volunteer on the registry. Currently, state law only allows the department to investigate and issue findings against an entity, not against individuals who work for the entity.

The Centralized Registry would be one piece of the overall comprehensive criminal history search process. It is intended to capture, after appropriate due process is afforded, negative civil information on certain individuals that may not be found elsewhere; effectively barring them from providing services to Alaska's vulnerable populations in licensed and/or certified entities or otherwise receiving monies from the department for providing services.
