Dear Senator Micciche,

The following information is provided in response to questions posed by Senate Finance Subcommittee members on March 10, 2015:

➤ ***Provide regional boundary change considerations.***

After more the 35 years the department's leadership team decided to look at the regional boundaries to see if they still made sense. The key factors that were analyzed were population trends and the changed focus of the recent highway bill (MAP-21). MAP-21 priorities for use of federal funds are the National Highway System (NHS), urban areas with a population greater than 200,000, highway safety and meeting performance measures. The population statistics from the Alaska Department of Labor and Work Force Development indicate that the Anchorage and Mat-Su will see significant growth in the next 30 years, with 72% of the state's population growth occurring in the more urbanized areas of the Central Region.

Central Region has the most complex operational, design and construction issues: the Whittier Tunnel traffic bottleneck, the Knik Arm Crossing, highway interconnection with Anchorage, expanding to four lanes in on many the NHS routes. Southeast Region has few NHS miles and will see a decrease in federal funded work.

In choosing where to draw the exact boundary – the department looked at the commonalities shared by coastal communities including Alaska Marine Highway service, harbors, ports, coastal maritime climate. While regional boundaries between Northern and Central Region are set by maintenance station locations, the department wanted to draw these boundaries along borough lines where possible.

The department can tweak the boundaries as we work to integrate new responsibilities and staff into the Southcoast region. A more strategic analysis of regional boundaries will be a part of the work the

department will do this spring and summer to centralize support operations and organize the department to provide the best service possible given the state’s new fiscal reality.

➤ ***Provide AMHS efficiencies that are being instituted.***

➤ ***Provide actual savings for the closing of gift shops and bars.***

Closure of gift shops will result in an estimated savings of \$1.1M. The average year savings is outlined below:

➤ ***Provide information on AMHS tariff structure.***

The AMHS Tariff Analysis completed January 2015 by Northern Economics compares AMHS rates to other similar systems worldwide. The study found that since 2008 AMHS operating expenses have increased by 33%, comparable ferry systems have increased passenger tariffs by an average of 27%, vehicle tariffs by an average of 8%, cabin tariffs by an average of 40-60% depending upon cabin location and type, and, most significantly, freight and cargo rates have increased by 236%. Average annual inflation in the US since 2007 has been 2.08%, and the Consumer Price Index in Alaska has increased 12% since 2007. AMHS has not had a tariff increase since the 3.2% increase implemented in 2007.

The largest issues with AMHS Tariffs are as follows:

- a) They have not kept pace with the economic realities outlined above,
- b) There are large variations in rates between comparable services (i.e. rate inequality, e.g. Adult fare for Juneau -Tenakee \$35 with a distance of 63 nautical miles, Whittier-Chenega Bay \$89 with a distance of 67 nautical miles),
- c) There is no standard formula based system for establishing or explaining existing rates.
- d) AMHS has very low freight/commercial shipping rates that undercut private transportation carriers (e.g. barges).

The implementation plan to address the Tariff Analysis recommendations is:

- a) Institute several rounds of leveling price increases (the first, a 4.5% increase effective 01 May 2015) that raise all tariffs except those that are currently 25% or more above the average per mile rate (i.e. bring up the lower rates to get less spread and variability while increasing revenue).
- b) Implement a commercial vehicle rate increase to avoid undercutting private carriers, and
- c) Implement a formulaic system to define and establish rates based on route length, demand, and time of year (summer/winter).

The new AMHS reservation and manifest system will go online in October 2015, and will facilitate the tariff changes, including the shift to a formula based tariff structure.

➤ ***Provide General fund amount / subsidy for AMHS FY2014 and FY2015.***

- FY2014 General Fund (UGF) authorized amount was \$108.9M
- FY2015 General Fund (UGF) authorized amount is \$107.8M

➤ ***National Environmental Policy Act (NEPA) Program Delegation - Is it necessary to put this forward this year? Demonstrate how it makes sense financially.***

NEPA Assumption

1. There are potentially 13 environmental assessments (EA's) that DOT&PF could assume
 - a) Anticipate we can save \$2M/year by getting thru the EA process quicker.
2. Federal Highway Administration's (FHWA) staff shortages, hiring freeze, lack of NEPA experience make their review and approval on EA's even longer than we have experienced in the past.
3. Have officially engaged with FHWA Alaska Division and Headquarters regarding assignment. Delay would require notifying FHWA that we are not interested at this time. Potential impacts:
 - a) FHWA would reassign their resources to other tasks and would be very hesitant to re-allocate resources until they are convinced we aren't going to back out.
 - b) Anticipate a greater effort needed to re-engage FHWA.

The department feels that it is in the best interest of the state to proceed with NEPA assumption. DOT&PF assumed responsibility for categorical exclusions 4-1/2 years ago and FHWA scrutiny and oversight is minimal. Since we sign the NEPA documents FHWA will not be able to override our decision.

➤ ***Have we considered being a distributor of fuel?***

DOT&PF maintains bulk fuel diesel tanks at Highways & Aviation stations statewide. Additionally we have unleaded tanks in the more rural areas where the cost of unleaded gasoline purchased from a local retailer is very expensive.

Neither the diesel nor unleaded gasoline stored in DOT&PF tanks is available to other agencies due to lack of a fuel management system which is necessary to bill other agencies for their fuel usage. The department will look into a fuel management system and determine if the return on investment warrants further consideration.

- ***Provide the utilization of the airports (enplanements), costs vs. revenue (subsidies by airport), and impacts on other airports with higher use. Provide a list of air strips maintained where no residents reside.***

Attached is a spreadsheet that provides information on rural airports. Enplanements are the number of people who got on a commercial flight and is the only data we have to indicate airport usage. Highlighted are those communities with no school, no health facility and who have no population data in the Community and Regional Affairs community data base.


➤ *How well utilized is the Akutan Airport and what is the cost to operate?*

The airport opened in September 2012. Between September 2012 and July 2013 no airfield use data is available. Between August 2013 and August 2014 – 624 air taxi operations occurred, no passenger count is available. Between February 2014 and February 2015 – 4,536 passengers and 226,595 pounds of freight have passed through the airport.

In FY2014 a budget increment of \$900.0 was received for the operation of the Akutan Airport. FY2014 actual expenditures totaled \$707.0. The FY2016 Governor's Amended budget request includes a reduction of \$155.6 for reduced operations at the Akutan Airport.
