### STATE OF ALASKA 2015 LEGISLATIVE SESSION

### Analysis

This bill would create a Marijuana Control Board housed within the Alcoholic Beverage Control Board agency. Under this structure, the executive director and staff of the Alcoholic Beverage Control Board would serve both boards. The board would be appointed by the Governor and have the authority to regulate marijuana cultivation, transportation, production, and sale.

If no board is created, the Alcoholic Beverage Control Board will have to absorb the regulation of marijuana. The cost for regulation of marijuana is included in the Governor's FY2016 budget request. Creation of a new board will not have a fiscal impact.
