Idaho: The licensee may complete his education courses efore or after exam, but cannot be licensed until he has successfully completed re pre-license education requirements. Kansas! 30-hour pre-license course for alesperson applicants who are not currently licensed in another jurisdiction rust be taken within 12 months prior to passing the exam. 30-hour Kansas ractice course for salesperson applicants can be taken before or after the exam ut must be taken within the 6 months prior to filing the application for licensure roker applicants who are not currently licensed in another jurisdiction must complete a 24-hour broker pre-license course within 12 months prior to passing the exam. Maine: sales agent only. Missouri: Salesperson must take a 48 hour prevamination course first and then must take the exam and a 24 hour Missouri eal Estate Practice Course in whatever order preferred before license application
