FISCAL NOTE ANALYSIS

BILL NO. HB 287

Analysis

HB 287 would amend provisions related to participation of the attorney general or the attorney general’s designee on the Controlled Substances Advisory Committee (AS 11.71.100) established in the Department of Law and by directing that a state prosecutor (other than the attorney general) with experience in controlled substance prosecutions be a member of the committee. The committee chair would be the commissioner of the Department of Public Safety rather than the attorney general. The committee, however, would remain as established in the Department of Law.

Similar changes would be made for the Criminal Justice Information Advisory Board and the Council on Domestic Violence and Sexual Assault, to remove the attorney general as a board or council member and instead designate a state prosecutor (other than the attorney general) with experience in certain criminal matters as a board or council member.

The Department of Law expects no fiscal impact to the department should this bill become law.
