BILL NO. SB161

Analysis

SB 161 amends an exemption in the construction contractor licensing law that allows those owning property, residences, or commercial buildings to act as their own contractor without meeting licensure standards.

Under current law, a property owner who acts as their own contractor may construct one home, duplex, triplex, four-plex or commercial building every two years, without a contractor license. SB 161 maintains this exemption, but requires an owner who advertises the structure for sale within two years, to file a form with the department stating that the owner is not engaged in a business that requires contractor licensing. The bill also directs the department to investigate and take action if circumstances indicate that the owner is operating a business for which a contractor license is required.

The Division of Corporations, Business, and Professional Licensing does not anticipate fiscal impact from this legislation.
