## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2015 LEGISLATIVE SESSION**Analysis**

HB47 would alter the interest rate that must be paid by certain municipalities on delinquent payments to the Public Employees Retirement System. Only municipalities whose population decreased by more than 25 percent between 2000 and 2010 would be affected. The bill is retroactive to July 1, 2009.

There is no anticipated fiscal impact to the Division of Community and Regional Affairs from this bill.
