I appreciate the difficult financial situation that Alaska is facing and your leadership efforts to resolve a budget deficit. I am a lifelong Alaskan who has lived through the rise and fall of our economy based on oil. I strongly support education and public radio as the priorities to create a healthy community and economy.
