#### Analysis

The bill was amended to remove the original section which would have required the division to print the amount of postage required to return a by-mail ballot. That section would have had an indeterminate fiscal impact on the division.

The remaining section of the bill repeals state law allowing political parties to purchase up to two pages in the Official Election Pamphlet. This has no fiscal impact on the division.
