Analysis

Section 1 amends AS 14.03, Public School Generally, by adding a new section, AS 14.03.016, A parent's right to direct the education of the parent's child. This section requires districts to adopt policies and procedures that allow parents "to object to and withdraw the child from an activity, class, performance standard, test, assessment, or program the parent believes is harmful to the child; a parent may object to an activity, class, or program as harmful if the parent believes the activity, class, or program questions beliefs or practices involving human reproduction, health, or sex education." In addition, parents could "review the content of an activity, class, performance standard, test, assessment, or program". Potential fiscal impact: loss of federal education funds under the Elementary and Secondary Education Act (ESEA), currently \$97.5 million.

Section 2 amends AS 14.03.110, Questionnaires and surveys administered in public schools, (a) by requiring written permission from the student's parent or legal guardian before administering a questionnaire or survey. There is no fiscal impact on the department.

Section 3 amends AS 14.03.110, Questionnaires and surveys administered in public schools, (d) by adding that parents can see the results of surveys or questionnaires. There is no fiscal impact on the department.
