STATE OF ALASKA 2016 LEGISLATIVE SESSION

BILL NO. CSHB 102

Analysis

This legislation adds a new section, AS 14.30.800, Contracts for educational programs at residential psychiatric treatment centers for a pilot program. Under this bill, a school district may enter into a contract to provide funding to a residential psychiatric treatment center for educational services provided to students that meet the criteria listed under (c).
AS 14.30.800 (e) provides for the final review and approval of contracts by the State Board of Education & Early Development. Under (f) a residential psychiatric treatment center may appeal to the commissioner and the State Board of Education & Early Development if the local school board rejects a contract.
Another new section, AS 14.30.810, Appeal of application funding, is added to establish the new appeal process.
The fiscal effect of this legislation is at the school district level.
There is no known fiscal impact on the public school funding formula under AS 14.17.
This legislation takes effective immediately.
