Good morning, my name is Jennifer Wooley. I am a local medical student, and will therefore not be able to attend the April 7th HSS hearing. However, I am particularly passionate about the issues addressed by SB 89, and would like to ensure that I contribute my testimony before the hearing.

As a lifelong Alaskan, a prior health educator, and a woman pursuing a career as a physician in Alaska, I understand the critical role of medically accurate, age-appropriate health education. Reproductive health and relationship skills are crucial components of health education, especially in a state like ours with unconscionably high rates of sexually transmitted infections and incidence of relationship violence. Beginning this education early, without stigma and with full class participation, helps elevate the conversation of health and wellness within relationships above misinformed whispers, and encourages a culture of respect.

In a perfect society, all children would have parents who are involved in their education and are well-equipped to guide them through the (often confusing) experience of learning about healthy sexuality and relationships. However, we must understand that this is not the case. Many of Alaskan's youngest and most vulnerable residents are completely dependent on the education they receive in the classroom to make sense of the world around them. Education at home may be absent, medically inaccurate, or age-inappropriate. Please consider these children, and the future they represent. As the Health and Social Services committee, it is the health and wellbeing of these children that should be the first priority. Requiring that their parents opt-in to class material keeps crucial knowledge out of their reach.

I sincerely ask that you do not let this harmful bill pass out of committee. It creates unnecessary barriers between children and the information that they need to be healthy. It removes well-trained, knowledgable educators from the classroom. It is in direct opposition to the intentions of the Health and Social Services committee. This bill offers a "solution" to a problem that does not exist. Parent's rights are not currently infringed upon; parents can opt-out of class now, if they so desire, and that is sufficient. Please consider the rights of the students, who have no political voice.

Representatives Seaton, Vazquez, Foster, Stutes, Talerico, Tarr, and Wool,

I understand that the House HHS committee will be taking testimony on SB 89 on Thursday. I am unable to attend or submit oral testimony at that time, but would like to give you my input on the topic.

I am an Anchorage gynecologist whose children were ASD public school attendees, and I have been an invited speaker many times at health education days for one of the local ASD high schools. Other volunteer representatives including Planned Parenthood trained health educators were there, and I was able to stay for their presentations. No "abortion providers" were present. Though it was not a formal school regulation, signed parental permission slips were required for attendance.

The speakers from Planned Parenthood were excellent, and at no time did they advocate for abortion. Questions from the students about abortion were deflected by all of us to be taken home as a more appropriate place to discuss this extremely value-based topic. Based on the questions many students asked, lack of basic information was rampant. Clearly, parents had NOT done a particularly good job at educating their students, and the overwhelming majority HAD given permission for their students to attend this volunteer health education day at which the organizational affiliations of the presenters were no secret.

If one connects the dots of the age of sexual debut, the high (and rising) rates of STI's in our state's teens, the inadequacy of most parents' skills at sex education, and the desire (by both students and parents) for such education, clearly we need continued quality sex education for this population. The individuals and groups that volunteer to assist the school district deserve support and thanks, rather than the intentional exclusion SB89 seeks. Do not make the efforts to educate our youth about opposition to abortion: abortion is not the agenda, nor a topic being recommended at these educational sessions. Quality volunteers in our community have stepped up to do their part, and should be applauded.

SB 89 should not advance.
