# STATE OF ALASKA 2016 LEGISLATIVE SESSION

**BILL NO.** SB 118

## **Analysis**

SB118 allows an individual, after submitting a survey for lease, sale, or disposal of land to the Department of Natural Resources (DNR) and upon being notified by DNR that they intend to review the survey, the option of having a committee of the Board of Architects, Engineers, and Land Surveyors (AELS) review the survey instead. DNR retains final decision-making authority.

This legislation instructs the AELS board to adopt regulations to establish procedures for convening a committee to conduct a peer review of a survey and establishes the criteria of members of the committee, and makes proprietary information and trade secrets contained in the surveys confidential. Regulations to establishes fees for peer review by the AELS board will be required.

This fiscal note provides for one Occupational Licensing Examiner, range 14, to manage survey cases, engage in a minimum of three professional services contracts for land surveyor consultants, manage the professional consultant contracts, and coordinate the review committee meeting and travel logistics.

If the bill passes the following expenses will be incurred:

Personal Services: \$77.8 (one full time permanent Occupational Licensing Examiner (OLE), range 14)

Travel: \$36.0 in the first year and \$72.0 beginning in the second year (one staff and three contractors to attend land surveyor committee meetings once per month)

Services: \$2.5 (legal costs to amend regulations, printing, and postage) \$25.3 in first year and \$50.6 begining in year two (three peer review contractors) \$10.0 (department-wide services support for one new position)

Commodities: \$5.0 in first year (computer, office panels, office furniture and other one-time needs for one new position)

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Licensing fees for each occupation are set per AS 08.01.065 so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
