I am a Home Visitor/Parent Educator for the Parents as Teachers Program in Anchorage. I work with up to 20 families in Anchorage who do not have access to any other Early Learning Program. Parents as Teachers is open to any and all families in Anchorage with children age prental-5 who want to learn ways to teach their children at home. Parents as Teachers helps families to prepare their children for Kindergarten, because when children start ahead in school, they stay ahead throughout. Many of the families that I work with are high-risk, and struggle with many things in their lives that affect their children, including OCS involvement, developmental disabilities, health problems, low income, teen parents, homelessness, and a history of abuse. If Parents as Teachers is eliminated in Anchorage then many of these families will have nowhere to turn for support. I get many referrals from OCS, PIC, and Head Start. These agencies cannot serve my families because they don't qualify for their programs because they are too young or the families don't have transportation to programs. Some of the families that I work with do not have any risk factors, but choose to participate in the program for the extra parenting support and the desire to give their children a Head Start in school. Parents as Teachers focuses on teaching literacy as well as promoting optimal brain development in young children. We also catch any delays early through health and developmental screenings that are done regularly at the home visits, and provide intervention to families and children, so that children can catch up by the time they reach Kindergarten so that they don't need Special Education Services in school. Eliminating this program in Anchorage will put these children in danger of "falling through the cracks" in our educational system later.

Please reconsider the budget cuts that will cause Alaska to lose its Parents as Teachers programs.

For the past 18 months, I have been a parent educator for the **Parents as Teachers** program at Kids' Corps in Anchorage.

Parents as Teachers is a program designed for parents from different social levels. Currently many programs are offered only for low-income families or for children with special needs. Our mission is to provide an opportunity to various socio-economic backgrounds. The program enrolls families from the middle class, families referred from the Office of Children's Services, foster families, grandparents, families who speak English as a second language, teen parents, and homeless families. We are also involved locally with different agencies such as; Programs for Infants and Children, Early Intervention ASD, Fetal Alcohol Spectrum Disorders, Crossroads High School, and the Child in Transition Homeless program at the Anchorage School District.

Our program works with families who are prenatal or have children from birth to 5 years old and help transition them into a preschool or kindergarten school based on the family's needs. Parent as Teachers has a curriculum that covers areas very important in the development of the children and shows parents how they can support learning through their home environment. We offer free health screenings: vision, hearing, heights and weights, and cognitive screenings. These help prevent and identify developmental delays from an early age. We encourage our families to attend community's events.

I have seen families grow together and become strong, and families who have learned to enjoy their children and play. I have seen families learn that education at an early age is important. I have worked with families who have learned to provide stable home routines and seen their children do much better as a result. I have worked with families who only needed support to achieve their goals and improve their lives. I see in every visit: incredible kids and families who experience less frustration and positive parenting. I believe as an Educator "The foundation of society is the family, if we have stable families will have a stable society with more opportunities and less delinquency". I humbly encourage you to take into consideration the power of funding Alaska's marketing efforts. We have taken advantage of numerous programs offered through past state tourism marketing budgets. From the visitor planner guidebook and travel planning website, to overseas sales trips, these marketing efforts have helped our company reach a broader, global market.
