I am writing in regard to a certain piece of legislature that greatly affects the well being of my family. The particular bill I write of today is bill HB4002; providing insurance to the surviving spouses and children of police officers and firefighters who die in the line of duty. It is with every hope and prayer that I have, that with this particular bill, if passed, will never have to apply to my family. However, if God forbid the unimaginable happened, I would feel much more secure in that we had something like this bill in place for my family to help us through what would easily be the most horrendous, difficult time of our lives. Recently this past year my husband had a very close call while on duty. My husband is a police officer and was intentionally struck by a drunk driver's vehicle while my husband was on foot trying to apprehend the suspect with his partner. Thankfully, only his knee was badly injured during the incident. Since then however, my husband has been going through intense rehab and has been out of work for nearly a year now. I am a stay at home mother to our 1 1/2 year old daughter and my husbands job is our only source of income. If we did not have the benefits his work provided we would be left with nothing. This past year has been an eye opener for us. Growing up the daughter of a policeman as well I am very familiar with the dangers of the job. But, when your husband has such a close call with what could have been disastrous to our family, it is a very big wake up call.

Bill HB4002 is something that I feel is necessary for the families of those who give everything, who risk their lives daily and run towards what everyone else runs away from. They sign up for this job, yes. For many, it is what they were made for and meant to do. These brave men and women willingly risk their lives daily so that others are safe, and in my personal opinion, so that the world may be a better place. My family was lucky that my husband was only badly injured and not fatally wounded. He was able to come home that night and return to our family. Unfortunately, for others, that is not the case. These brave men and women and the families that stand beside and support them day in and day out deserve to have that small sense of security in knowing that at the worst possible time of their lives, they at least have one less worry in terms of being able to take care of the family they have remaining, mourning, and will be taken care of by HB4002.

Please consider all of the families who have lost a loved one in the line of duty. Please consider all of the families of the brave men and women who go to work every day knowing it could very well be their last. Please consider the families who are left behind and the spouses who are left to hold everything together in a time of tragedy. This bill really hits home for my little family and I, and as I write this, with tears streaming down my face, I pray that you please look into all of the factors and vote yes to passing bill HB4002.
