Dear Representative Bob Lynn,

I respectfully request that you vote NO to Senate Bill 06 which would exempt Alaska from daylight savings time.

For the past 23 years, I have owned and currently operate a single plane single pilot air taxi business in Ketchikan. The majority of our business comes from tourism via the cruise ship industry. If Alaska adopts an exemption to daylight savings time the combined effects of early cruise ship departures for the entire summer and the loss of daylight hours in late summer would result in a loss of approximately 16% to 20% of our revenue. The aviation industry has a small profit margin and cannot sustain those losses.

Ketchikan has a total of 36 floatplanes being operated by 13 different companies. This bill will affect us all creating financial hardship and potentially putting many companies out of business. Additionally the economic trickledown effect on this community would be a huge loss.

A better alternative to becoming exempt from daylight savings would be for Alaska to remain on daylight savings time year round.

I implore you to vote against Alaska from becoming exempt from daylight savings time.

Dear Representative Lynn - I oppose Senate Bill 6, the bill to eliminate Daylight Savings Time (DST) in Alaska. I encourage the House State Affairs Committee to not advance the bill. If Alaska stays on standard time while most of the US changes to DST, it will complicate business and family communications, particularly with the Eastern US (including the federal government in Washington DC) as we will be five hours different for much of the year.

Of greater concern is the impact on Southeast Alaska, particularly if the elimination of DST results in SE Alaska moving to Pacific time. I remember when Juneau was on Pacific time and most of Alaska was on Alaska time. The Anchorage Chamber is an independent, 501 (c) (6) not-for-profit organization with a collective voice of nearly 1,000 business members representing over 50,000 constituents. A business-familiar, board of directors represents the members that make up one-quarter of Alaska's workforce, govern the Anchorage Chamber and ask that SB 6 not move forward for approval.

My name is Dan Fabrello, 2476 ODay Drive, Juneau, AK 99801. I have lived in Alaska since 1972 coming to Alaska when I was 3 years of age. I'm proud to call Alaska home and is a great place live and raise a family. I am writing on HB 64 exempting the State of Alaska from daylight saving time and opening up the possibility for the allowance of the US department of transportation to change time zones in Alaska as proposed in SB 6.

I am opposed to SB 6 and opposed to HB 64 and implore you to take action to reject and vote against this legislation of repealing/exempting Alaska from daylight savings time. If this legislation gets rammed down the citizens throats then the entire State needs to be on Pacific time and should be a condition of the bill and the ability for the US department of transportation to enact and separate Alaska into various time zones should be off the table. I've lived through the time changes in the 80's and this is a different State than those earlier days. We grew as a State during those days making one time zone for Alaska, minus the far reach of the end of the Aleutians, and I believe helped the economy of Alaska immensely. These two SB and HB bills as currently proposed are bad for Alaska. In a time of declining oil prices we must focus on bills that will help all Alaskans weather this slowdown in the economy not set up Alaskans for further failure. Our citizens are already separated from the rest of the Union (lower 48) by time and distance, enlarging this time divide creates a greater barrier and promotes further hardship to our citizens living and working within all of Alaska and that is a fact. Just this morning at my workplace our accountant had to do some financials with a company that we work with on the East coast and we needed to contact them and make a important decision and give them direction by 11:30am East coast time, 7:30am Alaska time, and is a time of day prior to our usual opening for the day. With the proposed legislation we would be even further separated from the rest of our Union and would have to pay someone to come in not a half hour early but an hour and half early to do this. That's just to contact someone just prior to noon East coast time! That is a hardship to employers. Who pays for this extra time to employees...not the legislature. We would be forced to live with the ramifications of this legislation though. This is just one simple example of the tip of the iceberg this troubling legislation will cause. If the bill passes and the US department of transportation is allowed to enact time zones across Alaska turning back the clock 30+ years this will be even further exacerbated the financial hardships this bill will cause Alaskan business not to mention our State employees of the permanent fund. Enacting legislation that unintentionally harms the economy of our State is simply reckless. One of the reasons I've heard and read is this legislation was proposed in regards to the health and well being of citizens suicide rate and heart attack rate from having to adjust to the 1 hour time difference twice a year. Won't traveling and dealing with 2+ hour time change for frequent travelers and professionals in and out of state be problematic in regards to health concerns? If the State moves to multiple time zones again, wont this cause a similar health concern to citizens when traveling between regions of our State? The logic proposed behind the bill as a health concern is flawed. If allowed to pass this legislation will cause even greater health risks to our citizens as they would need to adjust to a greater time change when traveling outside and inside of Alaska, if multiple time zones are enacted. Thankfully one time zone, Alaska Time, as currently enacted we only have to adjust twice a year to time changes. This twice a year time change will look a pittance to the amount of unintended financial consequences this legislation creates if allowed to pass.

Please reject the repeal/exemption of Alaska from daylight savings as currently proposed in SB 6 and HB 64 and keep Alaska time and daylight savings as currently implemented for the last 30+ years.

Dear State Affairs Committee,

When most of Alaska became a single time zone in the 1980s, Juneau left the Pacific Time Zone and lost an hour of after work daylight. Losing daylight savings time means another lost hour of useable daylight after work. Two lost hours of daylight from that most useful and useable time of day; after work, after school, after summer camp.

I'm not sure you are aware of this, but it rains a lot in Juneau. We are a light deprived people. Which is why the health based arguments for losing DST don't make a lot of sense to me - at least for Southeast residents. In addition to just the aggravation with the loss of two usable hours of light, those two hours of after work is time for a hike, a bike ride with the kids, a run with the family. Healthy things. Sure, we can do those things in the dark, and do, but really, we live in Alaska and evening light is like a birthright. If we're going to put up with the rain, the isolation, the winter ice factory that is Juneau, then - darn it - we should have a decent amount of light in the spring and summer to be good Alaskans!

The rest of Alaska is far enough north or far enough west for this action to have minimal impact. And I totally get it, whether the sun sets at midnight or 1AM is somewhat silly and changing clocks twice a year is annoying. But solving an annoyance for Northern and Western Alaskans delivers a gut punch to Alaskans living in Southeast. We'll have two hours of less usable afternoon light during the summer for people who are already severely light deprived and vitamin D deficient – I think you're going to have to budget for more mental health services.

I feel like I'm single handedly keeping the LED industry alive.

So I think the order of actions is backwards. We should first petition to the federal government to divide Alaska back into time zones, putting Southeast Alaska back into the Pacific Time Zone. That alone will give us one hour of afternoon daylight. Then, in the future, if you get rid of daylight savings time at least Southeast Alaska maintains the status quo. Otherwise, we'll have two more hours of evening light in the summer to fish, hike, camp, roast marshmallows, or watch whales. There's been a lot of testimony about the economic impacts to Southeast tourism businesses, and that's great stuff, but I'm just talking about quality of life and happy Alaskans. Don't force your fellow state residents, already a light deprived people, to deal with even less usable light. Thank you for your time and consideration.

I am writing this to all of you because I am represent an organization that has many members from each of your districts. I am the Softball Director for the Anchorage Sports Association. We are a 501 (C)(3) non-profit, member supported organization that provides the community with recreational sports programs. This proposed legislation to do away with daylight saving time would have a massive affect on both our high school and our adult softball programs. None of the 12 softball fields that we utilize are equipped with lights that would allow for game play after dusk. This bill, if passed, would have an effect on people's quality of life during our short Alaska summers. It would also greatly reduce the services we can continue to offer our members, your constituents.

Twenty years ago the Anchorage Sports Association entered into a partnership agreement with the Anchorage School District and the Municipality of Anchorage to form the sport of Fast-Pitch softball for the high school aged girls in Anchorage. We organize the league and do all of the scheduling for the eight Anchorage high school's varsity and junior varsity programs. This league runs from mid/late April until the end of May and typically consists of a 16-22 game season. We often do not get to start the season by our target begin date because we are removing snow from our fields and getting them into a safe, playable condition. This does not leave us much time to get in the required games. This proposed bill would lessen the available time we have to schedule these games for our high school teams as this sport cannot safely be played without ample light. We do our best to promote fast-pitch softball as an "outsourced" high school activity and are proud of the state to further their education. It would be a shame if these girls were not provided enough time and games to polish their abilities to display to the college recruiters who come and scout our state tournaments and view video tape of our players searching a scholarship opportunity.

Our adult program consists of approximately 250 teams which equals out to over 3600 adult softball players in our association. This does not include the other Anchorage softball players that play in the Anchor Town Sports Association's softball league which sanctions over 100 teams each year. Softball in Anchorage is a huge recreational activity and for many it is a way of life. We operate our leagues at near capacity each year and have a full slate of games going from the first week of May until the middle of August. During this season we have games that are scheduled as late as 9:45pm to fit every team's games in before the state tournaments begin

in August. This bill would end those games, potentially causing us to start turning teams away because we would not be able to schedule all of the games into the allotted time we have.

As a non-profit organization this loss in funds would greatly affect the services we provide. The other sports leagues we manage typically function at a financial loss. Softball is the only sport we offer that makes money and allows us to offer our other programs. If we are forced to reduce the number of our teams due to lack of field time this could no longer be the case. While we do not look to make a profit we still need to produce a steady enough revenue stream to support our programs and employees. This legislation puts our entire organization at risk. The cost to install lights at the softball fields would exceed that of which our members could afford and I am very doubtful the Municipality of Anchorage would fund any type of lighting to the fields.

After our regular season concludes we offer a "fall ball" league that is already limited to 36 teams due to field and light limitations. This bill would completely eliminate our ability to offer this league to our members. That would be a loss in revenue of approximately \$35,000.00 for just that league alone.

I have been contacted by many of our softball players that are very concerned with this legislation. This has become a quality of life issue that is greater than just the annoyance of having to adjust a clock twice a year. Speaking for the Anchorage Sports Association and softball players all over the state I urge you to take a look at the possible victims of this legislation. Summers in Alaska are already short and we as Alaskans do all that we can to enjoy our limited amount of time in the sun. This legislation takes away that ability.

I believe that daylight savings time was again instituted during WW II for the same reason(s).

Perhaps the reason we have it now is it helps business.

I personally strongly resent having my life artificially manipulated by folks who don't know me, don't know and don't care how I am being affected.

Certainly having daylight savings time is especially ludicrous in Alaska. Kids having to get up in the dark, or go to bed in bright sunlight. It is made worse due to the state pretending that there is no significant change in longitude for most of the state. The majority of the state's population resides around 150 deg West longitude, what should be two hours different from west coast time. But powers that be legislated the time to be one hour different than west coast time. (Heck, why not put the whole earth on Greenwich, England time and pretend the earth is flat. It would make it easier for commerce. I heard that the legislature of Iowa, once introduced legislation to make the mathematical pi equal to 3, to make things simpler.) The resultant being that during the summer, most of the population of Alaska is essentially on double daylight savings time, being two hours ahead of the standard time for 150 deg West longitude. Nome, at longitude 165 deg West. That is during the summer, the sun is at its highest in Nome at 3PM, not noon. Note that PM stands for post meridian. normally 3PM would mean 3 hours past when the sun crosses the meridian, but in Nome the sun doesn't cross until 3PM. I have been informed that their is a proposed bill that would eliminate Daylight Savings in Alaska. This would effect the cruise ship stops in Alaska by shortening their dock time and would have to depart Ketchikan earlier than current. The cruise ship dock time is already short and this legislation would only make it shorter. This would have a considerable negative effect on my business. With less business during the summer months I would have to cut back on the number of full time employees.

The Juneau Chamber of Commerce opposes the repeal of Daylight Saving Time.

The Juneau Chamber of Commerce represents approximately 400 businesses in Juneau. We have taken the time to survey our membership regarding the *repeal of Daylight Savings Time*. 31% of our membership responded to the survey with 75% voting against the repeal of Daylight Saving Time. (20% in favor, 5% no opinion).

Discussions with many businesses and organizations over this past month have all focused on the loss of an hour of daylight during the months of peak business and recreation. Flight operations, marine charters, and retail businesses related to tourism and recreational activities, especially on the shoulder months of March/April and August/September, will all be financially harmed with the loss of an hour of daylight.

In addition, creating a two-hour time difference between Alaska and the Pacific Northwest, and a five-hour difference to the east coast during this peak business period (or any period for that matter) adds further complexity and cost to those businesses needing to communicate with these areas of the country.

Whether it's personal recreation or chartered access to experience and enjoy the beauty and resources of Southeast Alaska, we all understand that it happens in the few short months of summer. Losing daylight at the end of our summer days takes away business opportunities and reduces our personal time to enjoy the quality of life in Alaska.

There is a logical compromise to achieve the repeal of Daylight Saving Time and ensure that we retain the hour of daylight, which is at the center of debate. However, the current version of the bill does not assure both and so the Chamber opposes the passage of SB-6 in its current form.

Dear Representative Lynn,

My name is Marc Cappelletti and I am the Director of Expedition Development for Lindblad Expeditions and National Geographic. I am writing with question and concern over Senate Bill No. 6, currently before the House State Affairs Committee, regarding the motion for the state of Alaska to exempt itself from observation of advanced time, or daylight savings time.

Lindblad Expeditions, in alliance with National Geographic, operates small ship expeditions in southeast Alaskan waters, and has done so for over 30 years. We pride ourselves on operating the most life-enhancing, immersive voyages in Alaska under the leadership of some of the region's most knowledgeable naturalists, historians and caring citizens. We take advantage of every moment to ensure that the approximately 2,000 travelers who join us each season are inspired by what they see.

Should Alaska choose to observe standard time instead of daylight savings time starting January 1, 2017, this will mean the loss of crucial daylight hours for our operation and others. The affects can be very immediate, like a reduction in runs for air taxis and tours, or more global, like a strain business relations between Alaskan companies and partners in other time zones. It will also strain entries into Glacier Bay National Park, frequented by thousands of travelers a day via large and small cruise ships, by forcing ships in the park at earlier daylight, long before anyone would be awake, in order to receive the full amount of daylight time in the park. Since the sun rises prior to 5:30 am at the latest throughout the summer, this only means the loss of evening light for those on a typical schedule. In our experience, even one hour of daylight can mean the difference between a once in a lifetime experience and a near miss.

Turks and Caicos recently addressed a daylight need that affected tourism, their number one industry, by shifting their time zone ahead one hour. This way tourists can have fuller days and enjoy sunsets later in the evening, instead of the typical pre-5pm sunset the island sees during winter months. It is perhaps a novel point, but at its core it benefits business. The motion from Alaska seems to do the opposite.

This said, I would be most appreciative for information on the benefits to Alaska and its businesses when considering this legislation. I believe it is a point that could benefit from further explanation and examination. Thank you very much for your time and for taking these points into consideration.

The mission of Juneau Economic Development Council (JEDC) is to foster a healthy and sustainable economic climate in Juneau and Southeast Alaska. The Board of Directors of the JEDC would like to urge you to oppose the passage of Senate Bill 6, exempting the state from daylight saving time.

We feel that this legislation will have unintended adverse effects on the tourism industry in the region. The loss of the extra hour of evening daylight during the peak months of business activity, particularly in May, early June, late August and September will have an economic impact on aviation, marine services and many retail businesses serving the vibrant tourism industry in our region. The loss of daylight will result in the loss of operating hours, business opportunities, and the concurrent loss of revenue for shore excursion, air taxi, and marine tour businesses. Shifting schedules to the earlier morning daylight will not substitute for the evening hour because of the undesirability of early departures. We anticipate a decrease in tourism-related business, which will trickle down to reduce support business revenues as well, and therefore reduce the amount of sales tax collected by communities. None of these adverse economic consequences are warranted while our state is facing economic uncertainty due to the state's fiscal situation.

Of further concern, this bill will create a two-hour time difference between Juneau and Seattle, and a five-hour difference between Juneau and the East Coast, for much of the year. This would reduce the time available to conduct business by an additional hour, and conducting business in a time zone that does not remain consistent with adjacent states could create additional confusion.

I write this letter to express the Greater Ketchikan Chamber of Commerce's opposition to the passage of SB 6 and our desire that CSSB 6(FIN). "An Act exempting the state from daylight saving time; petitioning the United States Department of Transportation to change the time zones of Alaska; and providing for an effective date" not be moved from the House State Affairs Committee.

Our Chamber works hard to promote economic diversity, regional growth, a climate that is good for business, a lifestyle that attracts year-round residents, and a stable, productive workforce. We strongly believe that the elimination of Daylight Saving Time will dampen our ability to further any and all aspects of this mission, and we are duly concerned about the impacts that the loss of an additional hour of daylight during the peak months of business activity will have on aviation, marine services, and many retail businesses serving the cruise industry here in Ketchikan. Further, the loss of another hour of daylight during the summer will negatively affect the overall quality of life for those who live, work, and do business in our region. Specifically, we are concerned about the following:

Alaska will stay on winter time year-round and thus will be two hours behind Seattle and five hours behind New York
when they shift to Daylight Saving Time along with the rest of the country. One result of this discrepancy will be that south-bound
cruise ships departing Ketchikan and Alaska for points south will have to leave an hour earlier to achieve parity with Pacific Daylight
Time, resulting in a nearly \$9,000,000,00 loss in revenues to our city and to Alaska.

• When these regions return to Standard Time we will be one hour behind Seattle and four hours behind New York as we are currently. This will confuse businesses and individuals across the country and complicate communications, particularly the scheduling of teleconferences and appointments. Businesses here in Alaska may have to shift their start times to earlier in the day for half the year (and then switch back) in order not to lose valuable time with partners farther East.

Sunset during the summer months will be an hour earlier than it is currently. This will detrimentally impact flight
operations, manne charters, tour businesses, and the safety of shift worker transportation. Individuals will lose time to participate in
valuable recreational activities that make Ketchikan and our region a special place to live, and those who depend on subsistence
activities will suffer both culturally and economically by darkness coming earlier. Similarly, commercial fishemmen will be forced to
shift their schedules and suffer the burden of having to wake up at 2 or 3 am in order to maximize their fishing time.

Financially, there will be a rise in programming costs to transportation, shipping, logistics, and broadcasting businesses.
 Municipal governments like our own will lose sales tax revenues, particularly as a result of losses in the tourism sector, and a negative "trickle-down" effect will damage sales at those businesses which support other, directly-impacted sectors.

Our Chamber understands the necessity of living within our means as Alaskans and advocates for reductions in state spending in order approach budget sustainability. Given that, we must to all we can to protect those parts of our economy that generate revenue for our state and our people. Now is not the time to raise logistical and technical issues for Alaska's businesses and taxpavers.

The only acceptable compromise is to ensure that if Daylight Saving Time is repealed. Alaska be moved to Pacific Standard Time, thereby preserving the hour of daylight that affects business and the overall quality of life for Alaskans during our most active months. This compromise, of course, is complicated by the size of our state and the fact that, internally, population centers such as Anchorage. Fairbanks. Juneau, and Ketchikan must be able to do business with each other efficiently (making multiple time zones an equality proposition). Our Chamber feels strongly that the best option for all Alaskans is to maintain Daylight Saving Time and continue as we currently operate.

On behalf of the Greater Ketchikan Chamber of Commerce and our community's businesses. I implore you to consider SB 6 carefully and do all you can to ensure that CSSB 6(FIN) "An Act exempting the state from daylight saving time; petitioning the United States Department of Transportation to change the time zones of Alaska; and providing for an effective date" stays in the House State Affairs Committee and is not passed during this legislative session.

Thank you for your service to Alaska and your attention to this matter.

I run a business which employs 25 people in Ketchikan, Craig, and Juneau. The loss of Daylight Saving Time would put Alaska 2 hours behind Seattle, and this can have a significant impact on the level of service we are able to provide to our customers.

In addition, the geographical location of Ketchikan, and all of SE Alaska means that we would lose an additional hour of daylight during our treasured summer months, especially in August and September. Our area already paid the price when we were taken off Pacific Time several years ago.

The impact on our cruise ship businesses would be significant as some ships would have to depart Ketchikan an hour earlier than normal in order to make their scheduled arrivals in Seattle and Vancouver.
