## Summary of Major Changes

- Redistricting Board: the work of the Redistricting Board was completed in FY 15. The board will be reconstituted after the 2020 census.
- Executive Office funding reductions have affected all line items and include the reduction in full time positions from 73 in FY14 to 60 in the FY18 Governor's request. Four of the affected positions are transferred to Shared Services in the FY18 request.
- The Contingency Fund has been reduced from \$800.0 in FY14 to \$550.0 in the FY18 Governor's request.
- Funding for the Domestic Violence and Sexual Assault Initiative was transferred, after a partial reduction, to the Council on Domestic Violence and Sexual Assault in FY16.
- Office of Management and Budget full time positions have been reduced from 18 in FY14 to 15 in the FY18 Governor's request.
- Division of Elections funding has been levelled by the legislature versus cyclical election funding of the past.

# Human Rights Commission

## AK Statute: 18.80

To eliminate and prevent discrimination in Alaska because of race, color, religion, sex, age, national origin, or physical or mental disability.

The Commission: 7 commissioners appointed by the Governor and confirmed by the Legislature. The Commission employs a staff and maintains an office in Anchorage. The Commission has statewide powers, and accepts and investigates complaints from individuals across all regions of the state.

- 363 complaints filed
- 452 cases closed
- Backlog to be caught up by March 2017 per HRC staff.

As the state's chief executive, the Governor is constitutionally and statutorily charged with overseeing the entire Executive Branch of Alaska State Government.
