#### I. SUMMARY OF NATURAL RESOURCES SECTION OIL & GAS WORK

The Natural Resources Section handles issues and disputes involving the state's proprietary interests in its oil, gas and mining resources. The Section protects the state's interests in oil and gas leasing, royalties, taxes and other issues. We advise our state agency clients and the governor, and are involved in litigation and also transactional matters with oil companies, environmental organizations, the federal government and others relating to oil and gas issues. Much of the tax and royalty information we work with is confidential under state law. We work with our clients from the start to the finish of a matter, not just after litigation has been filed.

**Staffing levels**: We are doing oil and gas work, the state's major revenue source, with far fewer attorneys today than three years ago.

In FY2014, 30 total authorized attorney positions were in the Natural Resources and Oil, Gas & Mining Sections.

In FY2017, after the merger of the two sections, 22 attorney positions are authorized and there are 19 attorneys actually working today.
