Why DLA Performed This Audit

The purpose of the audit was to determine if there is a need for the board's continued existence and whether its termination date should be extended. The board is set to sunset June 30, 2017, and will have one year from that date to conclude its administrative operations.

What DLA Recommends

All prior year recommendations were resolved and there were no new recommendations as part of the current sunset audit.

ORGANIZATION AND FUNCTION

State Board of Registration for Architects, Engineers, and Land Surveyors

The State Board of Registration for Architects, Engineers, and Land Surveyors (board) is a regulatory board consisting of 10 members appointed by the governor. The board consists of two civil engineers, two land surveyors, one mining engineer, one electrical or mechanical engineer, one engineer from another branch of the profession of engineering, two architects, and one public member.¹

Alaska Statute requires each board member to have been a resident of the state for three consecutive years immediately preceding an appointment to the board.

Additionally, except for the public member, board members must be registered and have a minimum of five years of professional practice in their field.

Alaska Statute 08.48.101 and AS 08.48.111 establish the powers of the board. They include adopting regulations for:

1. Describing the contents, conducting, and establishing a minimum score for passing examinations.

¹In November 2015, the board voted to introduce legislation to make the landscape architect representative a full voting member and increase the board to 11 members. Similar legislation has been previously introduced and has been unsuccessful. Currently, the Landscape Architect seat is a non-voting member authorized by the uncodified law of the State of Alaska by Section 31, Chapter 47, SLA 1998 (SB110).

2. Establishing bylaws governing its meetings and activities.
 3. Publishing a code of ethics or professional conduct for those persons regulated by the board.
 4. Establishing continuing education requirements for persons regulated by the board.

The board may issue registrations to architects, engineers, land surveyors, and landscape architects who meet the standards of education and training determined to be necessary by the board. The board may also suspend, refuse to renew, or revoke registrations.

Department of Commerce, Community, and Economic Development

By statute, the Department of Commerce, Community, and Economic Development's Division of Corporations, Business and Professional Licensing (division) provides administrative support to the board. Administrative support includes budgetary services and functions such as collecting fees, maintaining files, receiving application forms, and publishing notices of examinations and meetings.

Alaska Statute 08.01.087 gives the division authority to act on its own initiative or in response to a complaint. The division may:

1. Conduct an investigation if it appears a person is engaged or about to engage in a prohibited professional practice.
2. Bring an action in Superior Court to enjoin the act.
3. Examine the books and records of a registrant or an individual engaged in practices regulated by the board.
4. Issue subpoenas for the attendance of witnesses and records.

Alaska Statute 08.01.065 requires the department to adopt regulations that establish the amount and manner of payment of application fees, registration fees, permit fees, and investigative fees.

REPORT CONCLUSIONS

In developing our conclusion regarding whether the State Board of Registration for Architects, Engineers, and Land Surveyors' (board) termination date should be extended, its operations were evaluated using the 11 factors set out in AS 44.66.050(c) (included as Appendix A of this report). Under the State's "sunset" law, these factors are to be considered in assessing whether an entity has demonstrated a public policy need for continuing operations.

Overall, the audit found the board is serving the public's interest by effectively registering and regulating architects, engineers, land surveyors, and landscape architects. The board monitors registrants and works to ensure only qualified individuals practice in Alaska. Furthermore, the board develops and adopts regulations to improve the architect, engineer, land surveyor, and landscape architect occupations.

In accordance with AS 08.03.010(c)(3), the board is scheduled to terminate on June 30, 2017. We recommend that the legislature extend the board's termination date to June 30, 2025.

Detailed report conclusions are as follows.

The board operated in the public interest and does not duplicate the efforts of other entities.

Board operations were conducted in an effective manner. The audit found that from July 1, 2012, through February 15, 2016, the board held four meetings each year, which exceeded the minimum number required by statute. A review of eight board meetings held during the audit period found that a quorum was consistently achieved, meetings were public noticed timely, each meeting allowed time for public comment, and there were no vacancies in board positions.

The audit determined investigations were handled timely. There were 287 complaints open or opened between July 1, 2012, and February 15, 2016. Ninety-three investigations resulted from these complaints, of which 67 were closed during the audit period. Of the 26 open investigations, three were open for more than a year; however, records show that the three cases were actively worked by investigative staff.

The board was active in supporting statutory changes and proposing regulatory changes including:

-
- Chapter 36 SLA 13 amended AS 08.48.055(a) to include an investigator dedicated to the board; this amendment was supported by both the board and the department. Previously, the board shared one investigator with multiple boards. Having a dedicated investigator with knowledge of board statutes and regulations helps protect the public from incompetent and unlawful registrants and unregistered practice.
 - Regulation 12 AAC 36.106 was amended in March 2012 to include additional branches of engineering. This change was in line with national practices and helps protect the public by recognizing higher degrees of specialization within the engineering profession. The number of registration type designations increased from 12 to 21.

The audit also determined that the board does not duplicate the efforts of another governmental agency or the private sector.

The board registered businesses and individuals according to statutes and regulations.

The board also operated in the public's interest by registering businesses and individuals in accordance with state laws and regulations. From FY 13 through FY 15, the board issued 1,611 new registrations (see Exhibit 2). As of February 15, 2016, there were 7,386 registered professional architects, engineers, land surveyors, and landscape architects in Alaska. This represents a 28 percent increase in licensees when compared to the 2008 sunset audit.²

As part of the audit, a sample of 25 registrant applications was tested for compliance with statutes and regulations. All 25 renewed or initial registrations were found to have been issued in compliance with law. However, the audit could not confirm that the Division of Corporation, Business and Professional Licensing (DCBPL) staff monitored registrants' continuing professional education as required by regulation.

Regulations require five percent of applicants for renewal be audited to confirm continuing professional education was accurately reported. During the audit period, continuing education audits performed by DCBPL staff were not maintained. As a result, DCBPL's compliance with the continuing education audit requirements could not be verified.

DCBPL management and the board adjusted fees to cover the cost of board operations.

According to DCBPL management, as of FY 16, continuing education audits are documented in the new licensing system which maintains an electronic record of communication with registrants.

Primarily, the board receives its revenue from registration and renewal fees. Renewals are conducted on a biennial basis, creating a two-year cycle in board revenues. As shown in Exhibit 3, the board had a \$743,460 surplus at the end of FY 15, the second year of its biennial licensing period. In response to the surplus, fees were reduced for the FY 16 through FY 17 licensing period. Per DCBPL management, fee levels will be re-evaluated prior to the next registration cycle.

Exhibit 4 is a schedule of fees from FY 13 through FY 16. It shows fees were adjusted in FY 14 to address a deficit and in FY 16 to address a surplus. The FY 16 fee change was calculated using DCBPL's new fee calculation tool.

The audit evaluated DCBPL's tool used to set registration fees and identified potential weaknesses. The potential weaknesses include:

- Formula errors which do not correctly use registrant statistics for the applicable fee type.
- The estimated number of new registrants was based on prior year actual number of new registrants rather than an average over a period of time.

The FY 16 fee calculation was the first year the fee tool was used, and DCBPL management has since amended the process to correct the formula errors. In addition to correcting the formula errors found in the fee tool, DCBPL management should also consider using a full biennium of registrant statistics when projecting registrant levels.

Consideration should be given to making the temporary non-voting landscape architect a permanent voting board member.

Per AS 08.48.011(b), there are 10 designated board seats. The board registers four professions: architects, engineers, land surveyors, and landscape architects. All of the registered professions, except for the landscape architect, are represented on the board by a permanent voting member. To provide representation for the landscape architects, a temporary, non-voting landscape architect was established in

uncodified law.³ Since 1998, the non-voting landscape architect position has participated in all aspects of the board's activities, and related travel and per diem costs are reimbursed in the same manner as permanent voting positions.

Per the board chair, the intent behind the temporary board seat was to assist the board in drafting regulations and representing the landscape architect profession. The seven board members interviewed as part of the audit all support making the temporary board seat a permanent voting member. Board members believed it was important that each licensed profession be represented on the board by a voting member. Additionally, board members believed the input of a professional landscape architect on all board matters would be appropriate. Given that the landscape architect position has been an active board participant since 1998, consideration should be given to making the temporary non-voting seat a permanent voting member of the board.

FINDINGS AND RECOMMENDATIONS

The prior 2008 sunset audit⁴ made three recommendations:

- The Division of Corporations, Business and Professional Licensing (DCBPL) director, in conjunction with the State Board of Registration for Architects, Engineers, and Land Surveyors (board) should review registration fees as provided by statute and consider decreasing fees.
- The DCBPL director should ensure that the board registrants that are corporations, limited liability companies, and limited liability partnerships are licensed in accordance with state regulations.
- The Office of the Governor should fill vacant seats on the board in a timely manner.

The prior audit recommendation to decrease fees was addressed by DCBPL and the board. As noted in Exhibit 3, during the scope of the audit, board costs exceeded revenues, thereby resulting in a deficit in FY 13. Fees were increased in FY 14 to address the deficit.

The recommended improvement to registration for corporations, limited liability companies, and partnerships was implemented. The audit found that businesses submitted the required certification statement that documented a registered individual accepting responsibility for the business in the registered area of expertise.

Additionally, the prior audit recommendation to fill vacant board seats in a timely manner was implemented. The audit did not identify significant board vacancies during the scope of the audit.

There were no new recommendations as part of the current sunset audit.

OBJECTIVES, SCOPE, AND METHODOLOGY

In accordance with Title 24 and 44 of the Alaska Statutes, we have reviewed the activities of the State Board of Registration for Architects, Engineers, and Land Surveyors (board) to determine if there is a demonstrated public need for its continued existence and if it has been operating in an efficient and effective manner.

As required by AS 44.66.050(a), this report shall be considered by the committee of reference during the legislative oversight process in determining whether the board should be reestablished. Currently, under AS 08.03.010(c)(3), the board will terminate on June 30, 2017, and will have one year from that date to conclude its administrative operations.

Objectives

The four central, interrelated objectives of our report are:

1. To determine if the termination date of the board should be extended.
2. To determine if the board is operating in the public's interest.
3. To determine if the board has exercised appropriate regulatory oversight of architects, engineers, land surveyors, and landscape architects.
4. To determine the status of recommendations made in the prior sunset audit.

Scope

The assessment of operations and performance of the board was based on criteria set out in AS 44.66.050(c). Criteria set out in this statute relates to the determination of a demonstrated public need for the board. We reviewed the board's activities from July 1, 2012, through February 15, 2016. Financial information is presented, unaudited, from July 1, 2012, through February 29, 2016.

Methodology

During the course of our audit we reviewed and evaluated the following:

- The prior sunset audit report (ACN 08-20058-08) to identify issues affecting the board and to identify prior sunset audit recommendations.
- Applicable statutes and regulations to identify board functions and responsibilities, determine whether statutory or regulatory changes enhanced or impeded board activities, and help ascertain if the board operated in the public interest.
- The state's online public notice system to verify the board meetings and regulation changes proposed by the board were adequately public noticed.
- Board meeting minutes and annual reports to gain an understanding of board proceedings and activities, goals and objectives, the nature and extent of public input, whether a quorum was maintained, and whether board vacancies impeded operations.
- Expenditure, revenue, and fee levels for the board to determine whether fee levels covered the costs of operations.
- Investigation case data for the board to identify cases open for greater than one year.
- Various state and news related websites to identify complaints against the board or other board related concerns.
- Various state and federal websites containing information for potential duplication of board activities.
- Internal controls over the licensing database and investigative case management system were assessed to determine if controls were properly designed and implemented.

To identify and evaluate the various issues relating to board activities, we conducted interviews with state agency staff and board members. Specific issues of inquiry included board operations, duplication of effort, and complaints against the board. Additional inquiry was

performed regarding the non-voting temporary board member position and availability of exam locations.

The following samples were selected:

- A random sample of 25 initial and renewal registrant applications was selected from 7,495 licensees that were active between July 1, 2012, and February 15, 2016. Applications were assessed for statutory and regulatory compliance. The sample size was based on a low inherent risk. The sampled items were to include at least five corporate registrants. Test results were projected to the population.
- A sample of eight board meeting minutes was selected from 15 meetings held between July 2012 and February 2016. The systematic sample selected every other board meeting minutes beginning with the first meeting in FY 13. The sample size was considered appropriate as results of the review of board meeting minutes were significant to the evaluation of board operations. Test results were not projected to the population.

APPENDIX A

Analysis Of Public Need Criteria (AS 44.66.050(c))

A determination as to whether a board or commission has demonstrated a public need for its continued existence must take into consideration the following factors:

- (1) the extent to which the board or commission has operated in the public interest;
- (2) the extent to which the operation of the board or commission has been impeded or enhanced by existing statutes, procedures, and practices that it has adopted, and any other matter, including budgetary, resource, and personnel matters;
- (3) the extent to which the board or commission has recommended statutory changes that are generally of benefit to the public interest;
- (4) the extent to which the board or commission has encouraged interested persons to report to it concerning the effect of its regulations and decisions on the effectiveness of service, economy of service, and availability of service that it has provided;
- (5) the extent to which the board or commission has encouraged public participation in the making of its regulations and decisions;
- (6) the efficiency with which public inquiries or complaints regarding the activities of the board or commission filed with it, with the department to which a board or commission is administratively assigned, or with the office of victims' rights or the office of the ombudsman have been processed and resolved;
- (7) the extent to which a board or commission that regulates entry into an occupation or profession has presented qualified applicants to serve the public;
- (8) the extent to which state personnel practices, including affirmative action requirements, have been complied with by the board or commission to its own activities and the area of activity or interest;

- (9) the extent to which statutory, regulatory, budgeting, or other changes are necessary to enable the board or commission to better serve the interests of the public and to comply with the factors enumerated in this subsection;
 - (10) the extent to which the board or commission has effectively attained its objectives and purposes and the efficiency with which the board or commission has operated;
 - (11) the extent to which the board or commission duplicates the activities of another governmental agency or the private sector.

I have reviewed the April 27, 2016 Audit and agree with the findings. In reviewing the audit there are no new recommendations however there were three ongoing recommendations. In response to those recommendations, the AELS Board in conjunction with the DCBPL recently reviewed fees and lowered the fees to address the budget surplus. We anticipate fees either remaining the same or being lowered during the next renewal cycle, depending on the financial situation at the time.

The AELS Board recently passed regulations requiring corporations, limited liability companies and partnerships to place their physical address as well as corporate authorization number on all stamped plans. This will help to ensure those entities are properly licensed.

The AELS Board currently has one vacancy due to an unexpected departure. From discussions with the Governor's staff they are vetting candidates and forwarding for consideration shortly. A selection will be made as soon as possible however confirmation by the legislature will not occur until early next year.
