- Calls from customers 150K per year
- Online Services 168K per year
- Road Tests 18K per year (50% in house)
- Computer Knowledge Tests 10K a month with 54% failure (DMV doesn't charge for tests)
- Dealer Work 125K titles and registrations per year
- Overall 1.5 Million Transactions a Year

DMV Revenue

- DMV collected \$58 million in FY16
- DMV returned \$41 million in FY16 to the General Fund
- DMV FY18 budget: \$16.7 million
- DMV collects and distributes \$20 million on behalf of boroughs and cities that charge a motor vehicle registration tax
- Over 1.5 million transactions were processed statewide in FY16
 - o DMV Offices 74%
 - o Business Partners 15%
 - o Dealers 7%
 - o Commission Agents 3%
 - o Financial Institutions 1%

Business Partner Improvements


Business Partners (BP) are private businesses that do DMV work. They return money to the state and make money by charging customers for the service.

- 9 BPs with 13 locations 2 new this year
- 15% of DMV in-person business is done by BPs
- BP will be able to process driver's licenses and ID applications by end of FY17
- DMV continually looking to increase number of BPs and is actively pursuing new contractors

DMV Improvements: Online = No Line

- 11% of all transactions are handled online
- 3,000 more online requests from January 2016 to January 2017
- New Online Processes
 - Same Day Appointments 3 locations about 100 appointments a month
 - Driving record and disability tags
 - Duplicate license/ID coming March 1
 - Duplicate registration coming March 1
- Every process is being examined to update, refresh and improve to save time and increase accuracy
- Inventory Savings Fewer printed forms = more savings
- New ALVIN- Moving to new infrastructure on our main database in December 2017
