It's obvious that the legislature is far more interested in saving government than it is in solving current, temporary fiscal problems. Oil prices will go up again, but we will be stuck with a batch of taxes and other economic crippling "solutions" imposed by your legislation. Remember, the only real economy is in the private sector, not in government, because only the private economy can produce the income that government spends.

First off, there has been no serious attempt to determine where the State should be spending money. You can't build a budget until we decide how much government is necessary. That has been ignored in favor of creating ways to keep government funded. The fund will continue to grow, but all of that future growth will be sucked into the black hole of state spending. Not only that, but studies have shown your scheme will damage growth in the private economy by removing stimulus provided by the PFD. We are also ill-served by changing the funding source, making the PFD at risk for further confiscation. It is the height of irony that this Legislature is so focused on usurping a program that has been far more successful in directly helping Alaska citizens than any growth in state government has accomplished.

We desperately need fiscal responsibility in how our money is spent far more than the government needs increased or new taxes, and a takeover of the Permanent Fund.

Finance Co Chair Foster and Finance Co Chair Seaton,

Please pass on to your committee my concerns about the Budget which is open for public hearing right now.

I followed quite closely the elections that took place last fall and noticed without exception every candidate agreed that we needed to cut our State spending.

Your action recently to draw \$4 billion dollars from the PFD earnings reserve signals pretty clearly that you are willing to prop up a budget that is not sustainable. That is a problem. I am a farmer and I know that if I am spending more than my revenues I am in trouble.

It is evident that from your tax legislation you hope to increase revenues but I hope you understand that every penny you take out of Alaska's private economy to prop up bloated government is a major step into depression and non sustainability.

I urge you to consider legislation on the Senate side that projects a 20 year sustainable budget without new taxes or restructuring of the PFD. We are that close to realizing the original objective of the Permanent Fund- to sustain the private sector and the government needs with a renewable revenue derived from the income of our non renewable resources.

I would also like to point out that HB 115 not only introduces an income tax but it introduces a capital gains tax. I have heard little testimony about this but that actually bothers me more than the income tax. Capital gain taxes make it very hard to pass on farm property to the next generation. It also inhibits investing in property and development both by resident and non resident investors. A minimum 10% shaving from the profits of a property sale undermines the viability of many investments- especially in the farming industry.

Bottom line. Please cut government spending. You can cover deficit spending today with reserves but when those are gone you can not expect the private sector to carry \$4 billion dollars a year. That is a formula for disaster.

I'd like to say first that you took an oath of office to protect the Alaskans' rights and uphold the Constitution of this state and are contractually obligated to do so. They say it's important to get your message out early and then back it up with facts. So before your eyes glaze over let's get the core message of this testimony out of the way:

As a citizen, I believe that our priorities should be:

- 1) Continue to cut the Budget and reduce the size of State government.
- 2) There should be NO New/Increased Revenues (taxes, fees and fines) until you cut the budget so that it is below \$8.3 Billion.
- 3) Don't touch the Permanent Fund Dividend or Corpus. Period.

To House Finance ... Attached please find \$110+ million in savings identified in HB 57. It uses a simple 3.5% reduction on selected budget items. While private industry lays of thousands of people around the state, this seems like a minor sacrifice to remain employed. Ultimately the unions have 2 choices, fire employees, or get the unions to abandon the 'merit' increases.

Again: Cut the Budget, No New/Increased Revenues (taxes, fees and fines) until you cut the budget so that it is below \$8.3 Billion, Don't touch the Permanent Fund Dividend or Corpus.

Also attached is a copy of Senator Duleavy's plan. Additionally, I've attached the FY17-18 Fiscal summary, so that you may familiarize yourselves with it. It is obvious, from Tuesday night's purported activities in House Finance, that you have no idea how much money is in the Reserves funds. Please review page 3 of the Fiscal Summary - the Reserves - as prepared by Legislative Finance. What is becoming even more clear to me is that you have no interest in the impact of your plans to Alaska's private economy. Two separate economists have opined that the current proposed budgets, offered in the House and Senate, are among the WORST options for the State and do the most damage to the private economy. Thank you for taking public comments and testimony. While I appreciate the enormous task our legislators have for trying to balance the States' fiscal budget, passing on major expenses to the municipalities is not a solution.

The proposed amendment to HB57 to decrease appropriation for municipal school debt would pass an additional \$250,000 expense to Petersburg's taxpayers this fall. This would increase property taxes by \$90 for every \$100,000 of assessed value to our small Petersburg property tax base.

These State reimbursable bonds were issued to help pay for school major maintenance, a new aquatic center and a vocational education building expansion. The residents of Petersburg voted long ago on issuing debt for these projects with the assumption that the State would be reimbursing over 60% of the annual bond interest and principal expenses each year. Alaska municipalities issued bonds relying in good faith on the State of Alaska to live up to its financial commitments to education.

If the amendment to reduce State aid for school construction debt passes, it would also negatively influence voter approval of any future ballot propositions for construction projects in our community.

Please vote no on the amendment to HB 57 to decrease the general fund appropriation for municipal school bond debt.

I am a very concerned about the recent amendment that has been made to attack the Permanent Fund Dividend. I am especially concerned that the amendment has lumped so many different measures together; that it is an "all or nothing" proposition. All of the proposals basically say something to the effect of "the continued growth of our state government is more important than the individual citizens' right to determine how their money is spent!" Even during the recession years in the 1980's the state government did not attack the state's economy. Instead government tightened its belt and cut spending.

I do support preserving services essential to my clients and to Peninsula and all Alaskan communities and increasing revenue to pay for them.

As it is, a number of my clients live in a constant state of unease due to the rule hanging over their heads that they may be unseated from Assisted Living Facilities--a stepped up program that appears to have begun in 2014 to cut down on costs to the State of people who might be able to make it on their own. This practice stresses the atmosphere in the homes and creates uneasiness among residents. What this push to empty Assisted Living Facilities did and will continue to do is to put people back on the street that will still not be able to make it. They will end up being picked up or worse as they were not sequestered into Assisted Livings under false pretenses to begin with.

As well, this has put many Assisted Living Facilities out of business on the Peninsula over the last two years. The extra red tape stresses out the ALF owners whose main goal was to help people--not to fill out copious government reports for which they are hiring extra staff--which decreases their earnings. This is not the time to stop private business in this State.

The Mentally ill prospective clients will not qualify for the Home and Community Based Waiver but that program or one similar would take care of their basic needs--food, shelter(housing), transportation, heat, and someone to check in on them. This would help keep our jails empty--not a good prospect for private jails.....or state jails for that matter as they operate on head counts.

Dear Members of the House Finance Committee:

Please fund the 3 B's - BSA, Bond Debt Reimbursement and Busing (Pupil Transportation).

The governor's vetoes last session placed the full burden of school construction bonds on municipalities. In Anchorage's case, that was \$10.8 million. The Anchorage School Board choose to use our savings to pay for this; we are unable to do this again.

Pupil transportation needs to be fully funded. We have been subsidizing this from our operating budget for two years. As you know, the inflation proofing of pupil transportation sunset on June 30, 2015, but our costs continue to rise. Increased labor costs occurred when the minimum wage was raised due to the state law requiring bus drivers to be paid double the minimum wage. That resulted in \$2 million annual increased costs to the ASD with no additional funding. Last spring, we reduced routes and found efficiencies by changing the timing of other routes but when the governor's vetoes for transportation occurred, those savings were redirected to cover that loss in funding.

Please know that we have already passed our 2018 budget as we must submit it to the Assembly by the first Monday in March as per municipal code. If you have an extended session past May 15th, teacher contracts will have already been issued. It will be very difficult to adjust should cuts to the education budget be made after this date. The cuts incurred last summer with governor's vetoes came less than 48 hours before our fiscal year began. Please commit to passing a budget and fully funding the "3 B's" in a timely manner.
