Issue: Education

Hello, My name is Chelsea Vukovich and I am a resident and registered voter in Anchorage. As you continue on the daunting task of setting a state budget I would like to ask that the legislature keep in mind the ramifications of budget cuts to education and implore you not to cut education spending.

The state operating budget has been cut by almost 30% over the past two years. Alaska is already in a recession, and our unemployment rate is now the highest in the nation. For the long-term health of our Alaskan economy, we cannot afford further budget cuts, which mean more jobs lost.

-School districts around the state have had to reduce teachers, staff and expenses for the past five years due to flat funding of K-12 public education, and it is hurting student learning and outcomes. We need to invest in our students, not cut more!

-Support full funding of the BSA (Base Student Allocation) at \$5930 provided by this bill (which, when rising health care and other costs are factored, still means cuts in what that money can provide).

-Oppose the amendment to this bill that reverses state reimbursement for bond debt already issued. Almost **\$58 million** that voters were told the state would repay will be shifted to school districts under this amendment! This places a huge financial burden on school districts and will likely lead to many teacher cuts.

-Support the \$6 million in school funding this bill has added back to reverse a Governor veto of school busing funds. That allows school districts to spend more on teachers.

Fully fund base student allocation

Dear House Finance Committee Members,

I'm writing to you as a local school board member regarding the House Operating Budget. Specifically, I'd like to address the education portion of the budget. I strongly urge you to fully fund the base student allocation at \$5930. School districts across the state are already in the process of creating their budgets, and issuing teacher contracts. My district is in the middle of the budgeting process as well. We've already issued teacher contracts, so making adjustments and cuts now would be difficult.

We're a small school district. From talking to some legislators, it appears there is a frame of thinking technology will enable districts to cut costs. In the future, perhaps this may be true, though I'd hate to think of a school system where we're asking students to stare extensively at a computer/television screen, with limited human interaction. I believe we'd lose out in student engagement. Right now however, we simply do not have the infrastructure to recognize any cost savings without substantially losing in student achievement.

In my district, our internet service is delivered via satellite. Not only is this expensive, but bandwidth is so slow, utilizing online tools to enrich the learning environment is difficult. When it comes to online testing, the first year the state utilized online assessment, we had to shut down all internet functionality so students could test one at a time. We work extremely hard to utilize video conferencing when possible to take advantage of cost savings. When I first joined the school board, we would meet in person 3 times per year. Now, we meet in person once a year, in tandem with professional development, and the rest of the time via video conference. However, this has not been easy. There has not been a single video conference board meeting where we haven't had connectivity issues, with one or more sites getting disconnected, or sound being garbled. Every time this happens, I think of us asking students to put up with connectivity issues while we work to meet their educational needs via technology. While I think it's possible, savings won't be recognized until the digital disparity issues we face around the state are addressed.

In addition to fully funding the base student allocation at \$5930, I ask you to please fully fund bond debt reimbursement and pupil transportation. We are all hurting from the financial difficulties facing the state of Alaska, municipalities included. By shifting the full burden of school construction bonds to municipalities, I'm concerned local contributions to school districts may go down, further impacting public education. When it comes to transportation, for many of districts in Alaska have little control over cutting or reducing transportation services. They are what they are.

Finally, I thank you for the hard work you're doing. This is not an easy time in Alaska's history to be part of the legislature. I know the decisions you're making are hard and the time required to do this work is considerable. I thank you for taking our children's future, which public education plays such a large part of, as a priority as our children are Alaska's future. Fully funding the base student allocation at \$5930, as well as bond debt reimbursement and pupil transportation, are an important part of taking care of Alaska's future as well.

Honorable Representatives,

Thank you for your service and for taking the time to review my testimony.

I graduated from the University of Alaska Fairbanks in 2001 with a degree in journalism. I now work for the university's Statewide Public Affairs Office providing communications support for the president, Board of Regents, UA Scholars and many other aspects of the university system. As a result I am highly informed on the impact that budget reductions have had on the system and the urgent need to support the Regents funding request. I also understand the challenges the state is facing due to the severe loss of revenue. You have many difficult choices to make in prioritizing public spending.

State funding of the University has been cut by \$53 million (14%) over the last three years. While that may seem minimal percentage-wise, that is equal to nearly twice the University of Alaska Southeast's annual budget of \$27 million. The reality of these reductions are hitting the university hard. We have had to cut more than 900 positions and eliminate or suspend 50 academic programs.

I recognize that maintaining the current funding level of \$325 million is a recognition of the importance of funding the university, but I want to hit on why supporting the Regents' request of \$341 is so critical.

The Regents FY18 budget proposed a \$16.3 million increase to cover strategic investment categories - student recruitment and retention, critical facilities maintenance, competitive research capacity, K-12 education partnerships, and workforce and economic development - necessary to increase enrollment and retention, expand research capability and meet critical state needs. I support the regents long-term vision – their 10-year glide path as it is described – to gradually reduce reliance on state appropriations and build more university-generated revenue. This is critical for long-term sustainability, but cannot happen overnight and cannot happen with continual downward budget pressures.

Continued support of the TVEP funding authorization and Alaska Scholars Program also play into the long-term success for the university. So too will finally resolving the long standing land grant deficit. I look to your leadership and support in all of these critical areas of investment.

I have faith in the faculty, staff and leadership of the University of Alaska and believe that through greater collaboration and the successful completion of the Strategic Pathways process we will become a more efficient, stronger university meeting Alaska's needs. This is a turning point for the university and the state, and investment in the university today will support a more prosperous Alaska in the future.
