Senator Dunleavy and State Affairs Committee,

Alaska Legislators recently introduced several bills to restructure the Permanent Fund and use earnings for state government. This action must require the consent of Alaskans because Alaskans are owners of the Fund, according to Permanent Fund Corporation statements.

ONLY with the passage of SJR1 should Alaskans consent to the Legislature's proposal to use <u>Fund earnings for government spending</u>.
