As a special education teacher in rural Alaska, I have seen how Head Start and Early Head Start are crucial to the academic success and college/career readiness of disadvantaged Alaskans, particularly those who also experience disability. Early intervention has been demonstrated to be one of the most effective ways to improve outcomes for youths with conditions like Autism Spectrum Disorder and Fetal Alcohol Spectrum Disorders. Cutting funding for these programs will only lead to increased cost of care later, when interventions are more difficult and less likely to be effective.

Dear Finance Committee,

I have been a foster parent in Nome over the past six years and have enrolled four foster children in the Nome Head Start or Early Head Start Program. The Head Start program offers a safe place for foster children to socially/emotionally and academically grow with other children their age. Head Start helped me and other parents get our children's well child and immunizations up to date. After my foster children left my care, they continued participating in Head Start when they transitioned back into their homes or new placements. Head Start provided stability for my foster children when so many other things in their lives were not stable.

Nome Public Schools receives Pre-K funds and provides 3 certified teachers in the Nome Head Start and the Nome Preschool (approximately 80 children). The Pre-K funds we receive in Nome contribute to the entire Kawerak Head Start being able to fully staff 18 classrooms and provide jobs to 100 people in our region which includes the 11 rural communities of Brevig Mission, Elim, Gambell, Golovin, Koyuk, Nome, Saint Michael, Shaktoolik, Shishmaref, Teller and White Mountain. Up to 280 children benefit from Pre-K funds.

Please consider how the finance committee can meet the obligation to meet the needs of our children and families in the Bering Straits Region.

In the video, I ask her if she likes Head Start, and she said yeah. This was a biggy for our family, as this year was my daughters first year of Head Start.

Now before I get started about head start, I want to share a little more about my daughter. She was born a premie with medical issues which led her to having to be on an apnea monitor the first 6 months of her life. We kept her home all the time where she did not have much interaction with anyone because of her medical issues. As she got older, we took her out more. We also took her to a local child find held here in Nome put on at head start. There we had the opportunity to meet with Infant Learning where we later met to have other visits with concerns about my daughters speech, nothing went further because my daughter did not have major delays in her speech. Even though they were minor, we still had concerns and reached out to the Nome home based Early Head Start program. I knew about this program, being a former home visitor myself. This was one of the best decisions my husband and I made for my daughter. Through the home based program, my daughter was able to socialize with other children. She also had the opportunity to have a teacher come to our house to provide her with educational needs once a week. Knowing we had concerns with our daughters speech, the home visitor took the time weekly to help her with it. She even provided us with resources and educational materials to help her with her speech on our own time with her, and even then continued to support us and followed up with us on family and individual goals for our daughter. When my daughter turned 3, she transferred to the Head Start program where they continue to support my child and her education. You can't even tell she had minor speech issues and she is thriving daily as she is able to learn and socialize daily with other children and have her teachers there to support her as well. All this happened because we were provided the opportunity to get my child the education and support she needed through these wonderful programs. And just think, this is only one family that got the support we needed, can you imagine how many other families can benefit from this program?

In the video my daughter talks highly about teacher Linda. Teacher Linda is an amazing women who makes a difference in the childrens lives at head start. She's one of the reason why my daughter loves going to school daily and comes home talking about her too, saying nothing good about her. We need this program for our young children, especially when we have special teachers like Linda that want to be there to make a difference in the lives our our future leaders, so they too can make a difference as teacher Linda is.

In the video my daughter also says teacher Linda taught her how to sing her ABC's. I want to tell you this too is true. Senate Finance: Education and Early Development, Parents as Teachers Testimony

Good afternoon Mr. Chair. My name is Drew Hansen and I represent the RurAL CAP Parents as Teachers Program. With the current amendment to remove the Parents as Teachers program from the operating budget I would like to share with you and your colleagues some information on the program. This fall, in my search to find accurate rate of returns for home visiting programs I was introduced to a detailed analysis used to determine the cost-benefits of early childhood programs. According to the analysis titled "Return on Investment: Evidence-based Options to Improve Statewide Outcomes", for every dollar invested in Parents as Teachers, a \$3.29 monetary benefit is realized for participants and taxpayers. This analysis was commissioned by the Washington State Legislature to provide policymakers and budget writers with a list of well-researched public policies that can, with a high degree of certainty, lead to better statewide outcomes coupled with a more efficient use of taxpayer dollars. Based on the analysis of the Parents as Teachers program the savings come from the low cost of the model coupled with early identification and intervention, less grade retention, the prevention of child abuse and crime, as well as better long term outcomes in life.

There are immediate results from this program as well. RurAL CAP as a community action program across the state has the ability to screen and assess children in our Head Starts who have transitioned from our Parents as Teachers programs within the same communities. Through the use of both the DIAL, which is a developmental screening tool and the GOLD assessment, which is the statewide Head Start assessment for identifying school readiness skills, the data has revealed that Parents as Teachers children entering their next educational setting are more on target developmentally and have more skillsets related to school readiness than their peers who were not enrolled in the Parents as Teachers program. There are few investments that have the rate of return that early childhood programs like Parents as Teachers provides. Our children are Alaska's future. I understand you have tough decisions to make. At some point I feel additional revenue streams will be required to sustain needed programs within our state. We can only cut so deep. I appreciate your efforts to find the most cost effective methods to help strengthen our economy in the long term. Thank you for your time.

To Senate Finance Chair and Members:

Thank you for the opportunity to provide written testimony in regards to the proposed operating budget considered by the Senate Finance Committee. My specific concerns are related to the support of the preschool education and Pre-K Grants under the Alaska Department of Education and Early Development, Teaching and Learning Division.

Providing excellent pre-elementary programs for Alaska's youngest learners needs to be a priority, especially during these turbulent fiscal times. I have personally witnessed the overwhelming benefits and long lasting effects of preschool education in my own children, as well as the students in Chugach School District. Development of skills in the areas of pre-academics, social skills, and love for learning are critical for success, especially prior to entering Kindergarten.

As a current recipient of a Year 1 Pre-Elementary Development Grant for the 2016-17 school year, Chugach School District has just begun the process of incorporating necessary state support for our preschool program options. These preschool programs provide dynamic, relevant pre-elementary education that are based upon national and state standards, parent and community input, key professional development for pre-elementary staff, and braided streams of funding to build a powerful program to support our youngest students, including those with special needs. Parents, teachers, community members and administrators are in the process of completing the Strategic Plan for furthering the efforts of Chugach School District's Pre-Elementary Programs throughout all of our schools.

I respectfully request that you fully fund the Early Learning Pre-K grant budget in order to continue the support for our youngest students that receive limited support from the K-12 Base Student Allocation.

Dear Legislators,

Please reconsider cutting 100% of Early Childhood Funding from the budget.

I realize that the state is not mandated by law to fund Early childhood HOWEVER I also know the statistics for Early childhood and Head Start. IF you include a certified teacher such as we have for the PREK Grant the data clearly shows that these Preschool students are consistently for 7 years now of the grant AHEAD of their same age peers. In addition Kindergarten teachers report that these Early Childhood graduates are more ready for school and learning. The data shows that these students CONTINUE to show steady progress throughout the kindergarten year. In fact is there another educational program that can CONSISTENTLY SHOW YEAR AFTER YEAR that students are showing proficiency? This is a proven successful program.

Enclosed is the graph for kindergarten fall entrance for 2013. This graph shows Head Start graduates with the certified teacher in the classroom noticeably ahead of peers at time of kindergarten entrance. This data has been repeated every year. Below are the numbers for this past year's Head Start graduates going into kindergarten fall 2016 which show the same trend.

Here are the scores which show again this year that Head Start students score higher than the other groups when entering kindergarten.

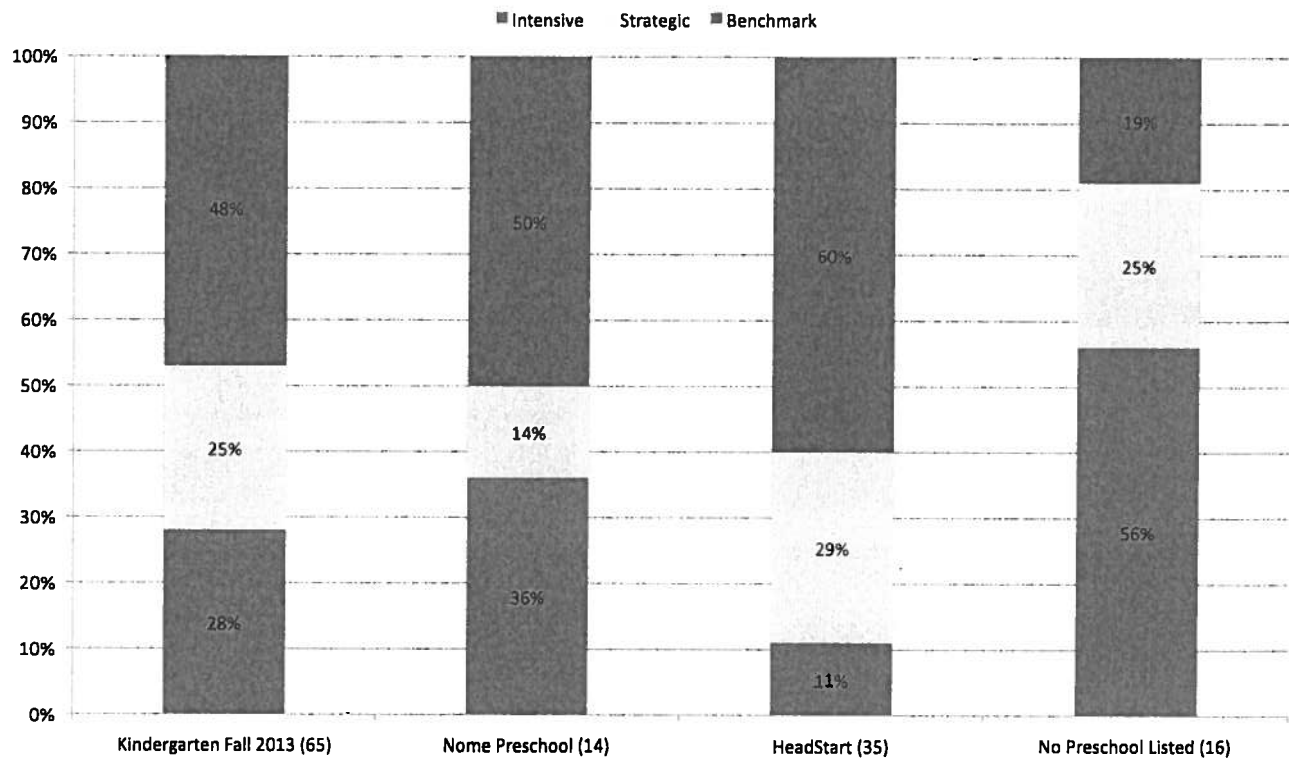
