FISCAL NOTE ANALYSIS

Analysis

HB 189 would allow the department to establish and collect fees to cover the costs of school bus inspections. The school bus inspection fees would be charged to a school bus operator. The department would collect the fee from school districts where the school district operates the school buses and would collect the fee from school bus contractors where the school district has contracted with a school bus operator to provide transportation services.

The department would start collecting the fee for inspections on district operated school buses after regulations become effective, in FY2019. Included in this fiscal note is \$4.0 legal service costs associated with these new regulations. The department would have to wait until a district entered into a new contract with a pupil transportation company before the department could start collecting the fee from the contractor.

The number of buses inspected each year varies, but on average there are 1,055 buses that are inspected each year. The department would establish the school bus inspection fee at \$175 per bus per inspection.

There are approximately 215 buses operated by school districts and approximately 840 buses operated by various contractors. The four largest school districts have recently entered into new contracts and buses inspected under these contracts (approximately 635) would not be charged the inspection fee until their current contracts expire in FY2026.

In FY2019 through FY2023, the 215 district operated buses, multiplied by \$175 and then multiplied for two inspections during the year would be \$75.3. In addition, for the contractor operated buses, there would be inspection fees collected for an additional 58 buses in FY2019 (\$20.3); 62 buses in FY2020 (\$21.7); 93 buses in FY2021 (\$32.6); 175 buses in FY2022 (\$61.3); and 205 buses in FY2023 (\$71.8).

The fiscal note does not include a reduction to the unrestricted general funds currently allocated for school bus inspections until FY2020, because the department is under contract with the inspector to provide inspections twice per year and there would be insufficient fees collected to meet the contract obligation if reductions occurred any sooner than FY2020.

HB 189 does not provide for an effective date.
