Dear Chairman Bishop:

On behalf of Governor Bill Walker, the Department of Fish and Game (ADF&G) respectfully requests SB 61 "An Act relating to the Izembek State Game Refuge, Cape Newenham State Game Refuge, Palmer Hay Flats State Game Refuge, Port Moller Critical Habitat Area, Egegik Critical Habitat Area, Pilot Point Critical Habitat Area, Fox River Flats Critical Habitat Area, Kachemak Bay Critical Habitat Area, and Dude Creek Critical Habitat Area; and providing for an effective date," be scheduled for a hearing in the House Community and Regional Affairs Committee at your earliest convenience.

The purpose of this legislation is to: 1) correct boundary description errors and properly describe areas intended for habitat protection, 2) eliminate the confusing patchwork of land status within these refuges and critical habitat areas, 3) create contiguous, inclusive boundaries that better reflect the original intent of the designations, and 4) remove lands inadvertently included in critical habitat areas that were not appropriate for habitat protections, and eliminate permitting requirements for such lands.
