Dear Members of the House Judiciary Committee,

I'm writing you today in opposition of HB 175.

First and foremost, this compact (and the bill) strikes me as an emotionally driven reaction of people who didn't get their way. In 2012 the Republican Party also talked about changing the electoral college when it appeared that their candidate (Romney) would have won had a different system been used. Democrats talked about it in 2000 when Al Gore lost the election. And on and on and on throughout our history - our founders had this same conversation! It never fails that the losing party thinks that there is a better way to conduct elections.

For the record: I'm one of those people who didn't get their way. I voted for Hillary Clinton, I supported Bernie Sanders in the primaries. I've been a Democrat most of my entire voting life. I was just as upset and shocked as everyone else who voted for Hillary when Donald Trump was elected President. I am still shocked and upset.

Moving towards a national popular vote is *not* how we change politics in America. As Americans we often talk about having things be equal – an equal and fair opportunity for all. On the surface HB 175 does that. One person, one vote. It makes sense on the surface.

But sometimes we have to work harder for those that have been disadvantaged (race, sex are the two big disadvantages that come to mind) so that they can have a seat at the table. The issue of battleground states is *not* improved by switching to a NPV – in fact it could get worse with political candidates campaigning only in major metropolitan areas. As a state with many people in rural areas this compact places them at a distinct disadvantage. Even further still, what candidate would seriously campaign in Alaska with a National Popular Vote? Elections are a game of numbers and we have a very small population in the grand scheme of things.

It is important to consider the impact this would have for Alaska as a whole. Currently Alaska's electoral votes represent .6% of the electoral college. If we move to a popular vote that percentage drops by more than half to .2%. This would leave Alaskans and our voices even more disadvantaged than any time zone issue ever has.

I personally believe that the issues we see with the Electoral College could easily be resolved by splitting the electorates of each state to align with the ratio of votes for each candidate in each state. No more "winner takes all" races but instead a race where one of Alaska's electoral votes could go Hillary and two to Trump. Nebraska, Colorado and Maine all have systems that accomplish this in some manner. I would support state legislation that enacted this.
