Attached is the amendment you requested.

You requested that the definition of "hashish oil" under AS 11.71.900(11) exclude cannabidiol oil. "Cannabidiol oil" is not currently defined under the Alaska Statutes. I have defined the term under AS 11.71.900, which provides that "cannabidiol oil" contains not more than 0.3 percent delta-9 tetrahydrocannabinol. This mirrors the restriction on industrial hemp under the bill draft. Is this consistent with your intent?

Be advised that the amendment changes the title in the second house, which is not permitted under the Uniform Rules. Therefore, a concurrent resolution will be required to suspend the rules against a title change in the second house if the amendment is adopted.

If you'd like a title change resolution, let us know.
