Industrial hemp is an important crop to bring back to U.S. farmers. Currently the U.S. is the leading importer of Canadian hemp for use in food and body care products. Dr. Bronner's, the leading producer of organic and fair trade castile soap in the U.S. imports approximately 22MT of hemp oil annually from Canada for use in our line of body care products. Our company employs nearly 200 staff in our Vista, CA factory, nearly 50 demo representatives around the country, and thousands of organic fair trade farmers through our supply chains. We reported approximately \$109M in 2016 revenues and conservatively project we will do \$110M in 2017 revenue. When viable option exists, Dr. Bronner's will start sourcing hemp oil domestically.

Each year Dr. Bronner's partners with the Hemp Industries Association, Vote Hemp and other leading hemp product manufacturers like Manitoba Harvest, Nature's Path Organic, Nutiva, Pacific Foods, Living Harvest TEMPT, CV Sciences, Farmer Direct Co-op, Tree Free Hemp, Onnit, Real Hemp, Lady Jane Gourmet Seed Co., Evo Hemp, Charolette's Web Hemp, Daily Greens, Good Seed Burger, Colorado Hemp Company, Green Spring Technologies, prAna, among others, in addition to retailers Whole Foods Market, INFRA, and NCG, among others on the Hemp History Week campaign. This public education and marketing campaign has distinguished industrial hemp from drug varieties of hemp while renewing strong support for the Industrial Hemp Farming Act in Washington DC. Since the campaign launched in 2010, we have seen the hemp industry grow from from an estimated \$419M in 2010 to \$688M in 2016 – a 64% growth over seven years – making hemp one of the fastest growing categories in the natural marketplace.

After President Obama signed the 2014 Farm Bill including the Legitimacy of Industrial Hemp Research, Section 7606, Hemp History Week has additionally partnered with Universities and Farms growing industrial hemp under state laws to highlight the return of industrial hemp to U.S. soils; these include the University of Kentucky, Rodale Institute, Growing Warriors (KY), Chimney Rock Farms (CO), Salt Creek Hemp Co. (CO), among others. Farmers, institutions and governments have noted the important benefits industrial hemp has to offer agricultural land including natural pest resistance and efficacy in breaking nematode pest cycles, limited water requirements, erosion mitigation, soil remediation, among other benefits.

The climate is ripe for the nascent U.S. hemp industry with a plethora of green technologies on the horizon with hemp currently being used for: graphene in supercapaitors, bio-composite car paneling for major U.S. auto manufacturer's, commercial and residential building materials, bioplastic, neutraceuticals, and more. It is high time all U.S. states involve themselves in the study and cultivation of industrial hemp, selectively breed hemp genetic stock according to bioregional fitness, research and develop hemp processing infrastructure suitable to the regional crops' industrial applications, and incubate locally-based businesses to compete in this growing marketplace.

It is worth noting hemp is most suitably processed within 100 miles from where it is grown, and with the further increasing demand for organic products, Penn State University has noted that "organic clusters", or areas with many organic farms as well as infrastructure to process yields, significantly increases income and decreases poverty in those areas. Therefore, a locally-based agricultural model including hemp farming and the proper support to adapt and invest in existing and novel infrastructure, could be a significant boon to Alaska's rural communities.
