SUBCOMMITTEE MEETINGS:

The House Finance Budget Subcommittee for the Department of Labor and Workforce Development scheduled 4 meetings and held 3 meetings with the Department during the review of the FY19 budget request.

RECOMMENDATIONS:

The Chair of the House Finance Budget Subcommittee for the Department of Labor submits a recommended operating budget for FY2019 to the House Finance Committee as follows:

Unrestricted General Funds (UGF)	\$20,624.2
Designated General Funds (DGF)	\$35,586.3
Other Funds	\$17,002.1
Federal Funds	<u>\$73,897.1</u>
Total	\$147,109.7

The Unrestricted General Fund (UGF) difference from the FY2015 Management Plan to the FY2019 House Subcommittee budget recommendation is a reduction of \$12,792.4, a 38.3% decrease.

The Subcommittee recommendation reflects a total decrease in Unrestricted General Funds of \$367.8, a 1.8% reduction from the FY2018 Management Plan.
