# University of Alaska Constitutional and Statutory Provisions

## Constitutional

#### AK Const. Art. 7, § 2 State University

The University of Alaska is hereby established as the state university and constituted a body corporate. It shall have title to all real and personal property now or hereafter set aside for or conveyed to it. Its property shall be administered and disposed of according to law.

# AK Const. Art. 7, § 3 Board of Regents

The University of Alaska shall be governed by a board of regents. The regents shall be appointed by the governor, subject to confirmation by a majority of the members of the legislature in joint session. The board shall, in accordance with law, formulate policy and appoint the president of the university. He shall be the executive officer of the board.

There is a constitutional mandate that requires the University of Alaska; that mandate does not break the university down into individual components.

The Alaska Supreme Court has held that this section is "the expression of the will of the people of this state that there shall be an institution of higher learning within the scope of the constitutional mandate providing for public education" and that the university "must be considered to be an integral part of the state educational system mandated by the constitution. In its constitutional status it stands as the single governmental entity which was specifically created by the people to meet the statewide need for a public institution of higher education." University of Alaska v. National Aircraft Leasing, Ltd., 536 P.2d 121 (Alaska 1975).

### **Legislative**

The University of Alaska is governed by Title 14 Chapter 40 in Alaska State Statutes. These statutes either require or authorize the University of Alaska to provide particular programs or areas of study. With one exception (Component #3, Office of Information Technology = Center for Information Technology authorized by AS 14.40.095), the component list is not directly equivalent to the specific legislative mandates. Instead, the individual legislative mandates form portions of one or more components. For example, the Institute for Circumpolar Health Studies mandated by AS 14.40.088 is a part of Component #5, Anchorage Campus. Another example is the Educational Expansion Program mandated by AS 14.40.055, which has been implemented in many of the 23 components.

Programs or areas of study that are mandated or authorized by statute are listed on the following page.
