In reply to your HAC & SAC facebook post I wrote: "Unfortunately the original PFD has already been killed by the AK Supreme Court. The Statutes have no teeth, since apparently the Leg can fund all or none of the Dividend. HJR 23 is a POMV with a 33/67 split, but it will never fly with the People. The Gov't wants a guaranteed income from the Fund. That's why they must have a Const. Amend. As it stands, only the Earnings can be touched. Go with a 50/50 split and both sides get what they want ! Is a POMV too risky ? Brad Keithley proposes a floating POMV...still 4.5 to 5% makes sense if the Fund can average 6.75 to 7.25%. Constitutional protection for the Dividend is the other Goal. I suggest that the Legislature receive for spending just what they are offering the People."

I realize the Permanent Fund Defenders are pushing to have the current statutes enshrined. The POMV restructure puts the Fund at a greater level of risk. Yet I believe both purposes of the Fund can be fulfilled, and done so equitably, that is, the Gov't can receive a steady stream of income, and the People can receive their Dividends unabated, without threat of under funding. There is no doubt that both purposes were intended historically and can be fulfilled going forward. (Hammond's 50/50 plan is still the gold standard.) That is what HJR 23 is attempting to do. SJR 9 comes even closer, with a 44/56 split.

While the demands on closing the budget deficit are at an all time high, this is no reason to establish an inequitable arrangement in the Constitution. With huge amounts owed in Credits (800 million) and now tax deductions annually (1 billion) to Oil, one must wonder where the priorities of our Gov't lie. A full audit would no doubt reveal where the largesse of spending has occurred after years of easy money. How to achieve a better relationship with Oil would seem to be a paramount concern, since we have a major short fall in revenue.

In conclusion, continuing to tap or tax the Dividend is the poorest of strategies, since it has been shown that the money is not currently needed for gov't spending, and those who benefit from the PFD are virtually all the People in our State, in one manner or another. It is a false narrative to claim that the Dividend must be taken or Alaskans will be taxed. Taking the Dividend is the most regressive tax that could have been devised. I applaud the efforts of the House in moving to reach a compromise. Now go the distance and enshrine the People's Dividend at half the annual distribution.

I read your post on Facebook and wanted to add my testimony.

I am a veteran and working father to 11 boys. (Yes, you read that right.) When I retired from the Air Force, I went to work for Halliburton straight out the gate. I loved oilfield work and we were happy in retirement. Well, you know the story with Big Oil -- two years later, I was laid off. At the very same time that my employment dried up, some in Juneau also decided to take a chunk of my PFD. We were depending on that money to get us through an extraordinarily hard time. While I am currently employed, it is no where near the income level I had with Halliburton and it isn't even near the income I had while still on active duty -- the economy here, as you know, is horrible and there aren't many "good" (high earning) jobs out there. (I suspect all my brethren who got laid off in the first several rounds of oilfield cuts took all the better employment out there and by the time I got my notice there was nothing left. Yes, I do, in fact, feel "triple affected" -- lost the oil job that I loved, there were no jobs because everybody else took them when they lost their oil jobs, and the state is taking my PFD because of the downturn in oil.) My family and I are still "starting all over again" after being laid off. That PFD is all that keeps us afloat.

For our family, that PFD pays for things like dental bills and copays, vehicle repairs (winters are rough on my commuting "beater with a heater"), and, quite literally, making sure I am able to put food on the table. We stretch the PFD out over 12 months simply buying food and keeping the bills paid. The PFD helps my family overcome Alaska's exorbitantly HIGH cost of living. Taking it away will devastate my particular family unit.

Which brings me to the million-dollar question that's burning on the minds of all Alaskans. I lost my income and had to make a new path with much less pay. My family had to make some seriously DIFFICULT choices in what we could and could not afford in order to keep ends meeting.
