Dear Senator MacKinnon:

The following information is provided in response to questions from the Senate Finance Committee on April 11, 2018 regarding House Bill 215:

- *Is there additional language that we should consider adding to the bill to bolster the intent that the fees are in support of the public health services that generated them?*

The Division of Public Health believes there is sufficient language to make the intent clear. HB 215 grants the Department of Health and Social Services the authority to collect fees to support the administration of public health programs by adding the fees to AS 44.29.022. The bill also makes clear that the program receipts collected would be used to support public health operations by adding the fees to the list of designated general fund program receipts in AS 37.05.146. Current law in AS 37.05.144, allows that the legislature may appropriate program receipts “to administer the programs generating the program receipts, to implement the laws related to the functions generating the program receipts, or to cover costs associated with the collection of the program receipts.” Further, AS 37.05.142 currently requires that the program receipts are maintained in a separate account by program source.

- *The division testified that the state doesn't have jurisdiction over screening devices at airports. What is the verification process to ensure the safety of airport screening devices?*

The Transportation Security Administration (TSA) is responsible for the safety of its airport screening devices. The TSA's airport scanners are exempt from state inspections because they belong to a federal agency.

TSA now uses millimeter wave advanced imaging technology and walk-through metal detectors to screen passengers rather than the somewhat controversial X-ray based backscatter

full-body scanners. Millimeter wave advanced imaging technology eliminates the use of ionizing radiation and uses electromagnetic waves (in the spectral region between radio waves and infrared) to detect potential threats. Millimeter wave advanced imaging technology meets national and international health and safety standards. The energy emitted by millimeter wave technology is 1000 times less than the international health and safety limits.

- ***Please provide an update on how the SHARP health care loan repayment program is functioning.***

The purpose of SHARP (Supporting Healthcare Access through Loan Repayment Program) is to address the worsening shortage of certain health professionals in the state by increasing the number of and improving the distribution of healthcare professionals who provide direct patient care. SHARP provides repayment of qualifying education loans and/or payment of direct incentive in exchange for a commitment to provide care in rural and underserved areas for two to three years.

Since 2010, Alaska's SHARP Program has provided loan repayment and direct incentive payments for 254 healthcare practitioners. During state Fiscal Year 2017 there were 145 clinicians under contract during at least part of the year. At the end of the fourth quarter there were 61 active contracts. Enclosed is information on the contracts from inception-to-date as well as quantity of services provided for state Fiscal Year 2017.

SHARP has two components. SHARP I contracts are funded with a combination of federal funds, employer match, and Alaska Mental Health Trust Authority. SHARP II, a state-funded option started in 2012, stopped issuing new contracts that require state undesignated general funds as a result of budget reductions. The statute that authorizes SHARP II (AS 18.29) sunsets June 30, 2019. A new option, SHARP III, which will not involve state UGF, is currently under development.
