BILL NO. HB 49

**Analysis**

HB 49 extends the statutory authority for the existing Board of Certified Direct-Entry Midwives through June 30, 2021. Adoption of the bill will continue existing activities by the board and administration by the division. If this legislation is not adopted, it will result in a one-year wind-down of the board in FY2018, and the division would assume all licensing responsibility in FY2019.

If the bill passes the following expenses will be incurred:

- Travel: \$4.3 (one staff and board members to attend two board meetings per year)
- Services: \$0.1 (advertising of public notice of board meetings)  
\$0.1 (honorarium/stipend for board meetings)

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Licensing fees for each occupation are set per AS 08.01.065 so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
