Representative Foster,

My name is Jacob Wilson. I represent the 930 Correctional Officers in the State of Alaska. Last year we provided a letter of support for what was then SB 4002. We were encouraged that Officers' families would no longer be hit twice if their husband or wife was killed in the line of duty: first by the death, and second by the loss of health insurance. The fact is that Correctional Officers put their lives on the line every day, just like any other Alaska Public Safety Officer. Their families are just as important.

A few days ago Correctional Officers became aware that they were no longer included in the new version of this Legislation. While we are happy to see at least some of our public safety families covered, it was a tough blow to see other law enforcement officers in the State covered because they are the ones who ... "run to the fire". With all due respect, Correctional Officers don't run to the fire, they live in it. The dangers Correctional Officers face are the same that every other Officer in the State of Alaska faces. Police Officer and Troopers may arrest the criminals, but it is Correctional Officers who keep them behind bars every hour of every day.

This would not substantially increase the cost of this legislation. While every year Correctional Officers are assaulted, some permanently disabled, we have been very fortunate not to have lost any Correctional Officer in an institution as a result of an assault. Because of this, I believe that the fiscal impact of covering our Officers would be minimal, but the impact on morale for the Officers would be immeasurable. It would give them peace of mind knowing that should they fall in the service of their State and give their life protecting Alaskans, their families would have insurance coverage.

In closing I would like to say we support HB 23 and hope that it passes. That being said, please include Correctional Officers in this legislation.

We also appreciate Commissioner Dean Williams' support of including Correctional Officers in this bill.





Representative,

I am in full support of HB 23 however, It is a great disappointment to learn that one of the largest groups of Law Enforcement Officers in Alaska has been recently excluded from HB 23. I am speaking of the nearly 1000 men and women who daily place their lives on the line while working in Alaska's prisons, the Correctional Officers.

Correctional Officers work everyday with the worst of the worst. Thieves, drug dealers, rapists and murderers. Many of whom have no problem assaulting, planning to or attempting to murder the Officers whose duty it is to keep the public safe as well as the the offenders in their care. I am one of those Officers.

Those of us who have chosen this profession understand the risks inherent with the job but that doesn't mean we don't worry about our safety or what will happen to our families should the worst occur. We work day in and day out, week after week, month after month for years with offenders, some of whom would have no problem taking our life if given the chance. They know us, recognize our faces, learn where we live, what we drive and who is in our family.

Many Correctional Officers have more than once been out in public with their family and been harassed by a former offender who was upset with them or one of their fellow Officers. Most of us are now hyper-vigilant and try to spot offenders before they see us so we can send our family's in another direction to keep the safe in case we have to confront the offender. We teach our spouses and children the signal to get away from us so we can protect them if needed.

The dangers Correctional Officers face everyday are no different that those faced by any other Law Enforcement Officer on the street. I have been surrounded by a dozen offenders who were angry at me for enforcing the rules of the facility, I have been threatened with physical assault if I were to open a door and let an offender near me. I have more then once been threatened by offenders that they would "find me on the streets" or they would "get me on the outside". We have chosen this career and we aren't afraid but we do want to be able to provide for our families should the worst happen.

I encourage you to rethink the decision to remove this vital group of LEOs from this bill. Our families deserve to be cared for just as much as a Trooper, City Police Officer or any other first responder stationed anywhere else in the State of Alaska covered under this bill.

Representatives,

I received an email last night from my union that was updating me on the "Law Enforcement Survivors' Bill". It was quite disappointing to see that Correctional Officers were removed from the bill. I don't understand why we would be left off. We put our lives on the line every day we put on a uniform. Many of us step into situations where we are faced with a 100 sentenced or unsentenced prisoners every day. The numbers are not in our favor and we have no means to protect ourselves. We are assaulted, spit at, have feces thrown on us, and any number of other things you can think of. We have had broken jaws, broken arms, shoulder injuries, knee injuries, needle sticks and any other thing you can think of. Jamie Hesterberg gave his life for this state during a Prisoner Transport many years ago. I have just entered my 22nd year of service and I myself have had a hand injury, a knee injury, spit on, and assaulted. All of this to provide for my family and to protect the people of Alaska, including yourselves.

I believe the least that could happen is to know that someone cares enough about an officer's family to ensure they are taken care of in the horrific event their life is taken from them by the hands of someone who has been locked up away from society. Everyone else's life will go on as if nothing happened while the officer's family tries to piece together what they have left. Even a small token as being covered by Health insurance would go a long way and ease the financial burden that they may face.

I appreciate your time and hope that the bill can change to include Correctional Officers. We are part of the Law Enforcement Community and we do our part to help keep Alaska's Criminal population in check.

RE: CS for HB 23 – An Act creating a fund in the Department of Public Safety; providing for payment of certain health insurance premiums for surviving dependents of certain police officers or firefighters who die in the line of duty; and providing for an effective date.

Dear House Finance Members,

Firstly, we in municipal government value and honor all of our first responders. They tirelessly commit their efforts by risking their lives to keep our communities safe.

It has come to our attention that HB 23 has changed considerably from last years' version submitted by the Governor. This newer version has set up an unfunded mandate which (under the circumstances of cost transfers from the State to municipalities; the decrease of revenue sources; and the removal of indirect education funds which now must be covered by municipalities), makes it difficult for us to assume another new mandated expense.

We have a few concerns which I will try to line out in this letter.

1. Fiscal note – We are uncertain how this “fund” will work. Will money be deposited by each community on a regular basis or will money only be deposited into the fund if and when there is a public safety accident involving a municipal police officer or firefighter? AML requests that House Finance provide us with a “municipal fiscal note” showing forecasted costs to local governments. Under Section 39.60.020, it is stated that the commissioner shall “determine the amount of money sufficient to pay premiums under AS 39.60.030 and the associated administrative costs. We would like some sort of a fiscal note to allow us to know what kind of costs we are facing. Also, what would be the definition of “associated administrative costs” and what would be the estimated amount of those costs?
2. How would this impact municipalities within the negotiation process of collective bargaining? Isn't survivor health insurance a legitimate collective bargaining item?

Due to the inability of municipalities to plan, as we find ourselves completely unsure of our fiscal situation until the entire session has been completed, without some sort of cost estimate, we cannot support an additional unfunded mandate. The noble impact of the mandates is not the issue. The unfunded mandate IS the issue.
