I'm asking that survivors of corrections officers who are killed on the job have their health insurance coverage continued at the same level it was at the time of the death.

I was trying to find an eloquent way to express myself in proving how dangerous the corrections officers job is and sadly, fate provided me with proof. Yesterday I woke up to the fact that 4 corrections officers in Delaware were being held hostage by the inmates. In the end, one officer's life was taken and the others were injured but survived.

Please reconsider this bill and include our corrections officers as part of the brotherhood of law enforcement.

Hello,

My name is Chris Bottoms. I am a Correctional Officer at Goose Creek Correctional Center.

I am concerned about Correctional Officers not being included in HB 23. I agree that police officers should have a benefit because of the direct threat that they face every day.

Many people, however, don't consider the potential danger that correctional officers face every day. I know police officers that say that they would never want to do my job because of the potential danger. Our facilities receive the same people the police are dealing with after they have been arrested. Many times they are angry, high, drunk, detoxing, or all of the above. We do our best to handle these situations armed with nothing more than pepper spray.

There are many other potential dangers to consider as well. At our facility, we have over 1200 inmates. Our housing units have 128 beds, 1 officer, and none of the doors can be locked. I have had murderers housed in the room directly behind where my work station is located. Those factors, coupled with the seemingly unstoppable flow of drugs into our facilities, is a potential recipe for disaster.

As a transport officer, I am also responsible for the safety and security of inmates in public places. Hospitals, clinics, and private doctor's offices are among the places we go. Some of these appointments, such as dialysis, are regularly scheduled. This increases the risk exponentially.

I know that we are the forgotten of the law enforcement community, but we do our part to assure the safety of our prisoners, our staff, and our communities.

My name is Jason Forster. I am currently a Corrections Officer at Goose Creek Correctional Center. I started my career atSpring Creek Correctional Center in 2001. I have since then worked at Anchorage Jail, Mat-Su Pretrial, and Central Transportation. I am currently at Goose Creek Correctional Center working as the facility's Transportation Sergeant. During my tenure I have been spit on, assaulted and have had to respond to countless assaults in progress, including prisoner on Officer assaults as well as prisoner on prisoner fights. I have had urine and feces thrown on me. I have been exposed to a myriad of blood borne pathogens. The constant element of danger is very real. Beyond the simple logistics of being completely outnumbered, should the temperament of the prison population darken, there is also the potential for many different handmade weapons many of which I have personally confiscated. On numerous occurrences offsite from the facility I have responded to vehicle accidents and helped Police Officers in need on the side of the road while working as a Transportation Officer. Again the constant element of danger is real.

Working inside the confined walls of a prison is not an easy profession. We as Correctional Officers have to wear many hats day to day. We are counselors, role models and first responders in just naming a few of our many responsibilities. Just like all law enforcement professionals we to took an oath of office.

I sincerely hope that you reconsider the removal of Corrections Officers from bill (HB23). The re-implementation of Corrections Officer on bill (HB23) will help give our families, ourselves, and your constituent's peace of mind as we walk through the doors to wear our multiple hats behind the walls of the prison.

I would like to start by thanking Representative Millett for all the hard work she has put in on this issue over the last several years. I want to also thank Representative Josephson for carrying this forward.

I am writing today to support HB 23. HB 23 provides a much needed and long overdue fix that will provide health benefits to the spouses and dependent children of Police officers and Fire fighters who are killed in the line of duty. The is near universal agreement that these benefits should be provided in statute. The way the staff at retirement and benefits explained it to me is that this problem is the result of an oversight. The benefits were previously provided in Tier 1 but language dealing with actives who die in the line of duty was accidentally left out when new tiers were crafted. The state and a few municipalities have provided these benefits on a year to year basis since it was discovered that coverage did not exist in statute. This methods requires families and those who advocate on their behalf to yearly revisit the pain of losing a loved one in the line of duty in order to remind elected officials of their sacrifice and the need for these benefits. It is time to fix that problem and HB 23 will do that for all municipal and state police officers and fire fighters..

I know the municipal league testified against being included in this bill. On one hand they talked about how they are providing these benefits in cities like Fairbanks and Hoonah and always will and on the other hand they said they can't be forced to pay these benefits. Those two thoughts do not make sense. Once you hire a police officer or a fire fighter you accept that responsibility. They should know that their employer is going to take care spouse and children should they make the ultimate sacrifice. Regardless of whether they work for the state or a municipality.

However, there is a missing piece in this legislation that I would ask you to address by amending the bill to add Dept of Fish and Game personnel who die in the line of duty.

Pete Winslow, Ralph Reischl, Randy Kacyon, Lester Varozza, John Frank, Arthur Bratlie, Hugh Oneil, Lee Larson, Valerie Chatbot, Ruth Southern, Edwin Strong, John Solf, Ken Friedrich, Gary Wohlfeil, Shelli Clay, Leroy Bohuslov, James Erickson, Kim Bussell, Lloyd Stebbins, Lloyd Lewis, Spencer Linderman, Doyle Cisney, Rex Thomas, Johnathan Ward, Jack Geil, Robert Lawler and Kevin Kivisto are the 27 Alaska Dept of Fish and Game staff that have lost their lives on the job. I invite you to visit their memorial plaque at ADF&G headquarters.

ADF&G has lost more staff than any other state agency, including the troopers who we work closely with, due to the extensive time spent in aircraft, on the water, and in the field.

Dangerous work in boats, in aircraft, diving, and conducting field work is a routine part of our work duties to maintain and sustain the fish and game populations in Alaska that Alaskans rely on for food and livelihoods. I have personally saved one person from drowning while collecting data, have visited a colleague in the hospital after being severely injured in a plane crash while performing aerial surveys, picked up a friend and coworker from a float plane to transport to the hospital after being mauled by a bear while walking stream surveys. There are many such instances and I could go on but I think hopefully you understand that these are just a few of the dangers we face while performing our duties as a state employee within ADF&G.
