


Department Overview: Corporations, Boards, and Authorities

- Alaska Housing Finance Corporation (AHFC): Invest and Distribute
 - 314 PFT, 22 PPT, 14 NP
 - \$99M operating budget, 61% Federal funded
 - Many capital projects
- Alaska Permanent Fund Corporation (APFC): Invest
 - 57 PFT, 2 PPT, 2 NP, \$18M operating budget (0% GF) + management fees
- Alaska Retirement Management Board (ARMB): Invest
 - \$10M operating budget (0% GF) + management fees
- Alaska Municipal Bond Bank Authority (AMBBA): Distribute
 - 1 PFT, \$1M operating budget (0% GF)
- Alaska Mental Health Trust Authority (AMHTA): Distribute
 - 24 PFT, \$6M operating budget (18% GF)

Department Overview: Recent Accomplishments

- Tax Division
 - Supported 22 tax types (~21,000 taxpayers, ~32,000 tax returns), developed a plan to improve efficiency with O&G production tax audits, first full fiscal year of collecting marijuana taxes (\$11M)
- Treasury Division
 - The State's credit rating stabilized in FY18 with the adjustment of the outlook from negative to stable
 - As of 12/31/2018, managed \$38.8B in assets in 45 separate accounts in a pooled environment
 - AMBBA issued \$29M in bonds resulting in loans to communities, \$3.4M saved due to lower interest rates
 - \$16.5M was transferred into the General Fund from Unclaimed Property, \$152.6M transferred since 1986
- PFD Division
 - Improved application design will reduce follow-up requests of applicants, increased online filing by eliminating electronic access roadblocks, and included the new Education Raffle as one of the optional giving opportunities
- Child Support Services Division
 - Updating the division's information system (NSTAR), scheduled to complete in 5/2019
 - Customer Service Center receives 18,750 calls per month
 - 80% (15,000/month) addressed through automated IVR process
 - 20% (3,750/month) addressed by call center employees and caseworkers



Department Overview: Challenges

- Tax Division
 - Significant O&G tax changes (e.g. HB 111) requiring drafting new regulations, reprogramming, and testing
 - Forecasting oil and gas markets during volatile time periods
- Treasury Division
 - Managing investment risk in the current low interest rate environment and during market volatility
 - Maintaining and improving the State of Alaska's credit rating
- PFD Division
 - Modernizing technology
- Child Support Services Division
 - Successfully complete replatforming of the division's information system (NSTAR)
