**Alaska Wildlife Trooper**

I have recently assumed a Lieutenant position within the Department of Public Safety, stationed in Soldotna, Alaska. As a Deputy Commander within Northern Detachment my duties include supervising 21 Troopers and civilians.

Duties associated with my current position also include but are not limited to preparing comprehensive action, response, and operational plans for my detachment. Plan for expected, seasonal; and unforeseen events such as; fish and game, or traffic enforcements; disasters; search and rescue missions; and major crime operations.

Manage and participate in multiple enforcement and fiscal programs. Review and/or prepare performance evaluations, hiring requests, transfer requests, resignations, worker's compensation, and other personnel management activities. My current position is responsible for communications among enforcement components within the detachment and exchange information with other police organizations and agencies.

Direct and coordinate law enforcement and civilian personnel on major enforcement missions. Coordinate agency enforcement activities with appropriate law enforcement agencies. Provide a direct field-enforcement presence in major enforcement programs or events.

Assist in managing budgetary allocations and controlling expenditures for personnel, equipment, overtime, travel, and special enforcement missions; oversee the review and approval of financial coding and billings; draft correspondence, policies, and procedures; and administer federal grant and related special program funds.

Liaison with local, state, and federal law enforcement agencies, the courts, and social-service agencies. Represent the detachment or program on multi-agency committees.

Prior to my current position, I was a Sergeant at the Soldotna AWT Post where my duties have included but are not limited to directly supervising 4 Troopers, one permean Public Safety Technician II, and one seasonal Public Safety Technician I.

In my capacity as the supervisor for the Soldotna Post, I have been responsible for the Troopers case management and review, personnel inspections, evaluations, post equipment, overtime management, and policy and procedure compliance. I was also tasked with the Sergeant duties for Prince William

Sound in addition to my duties at the Soldotna post where I supervised two additional Troopers and one additional permanent Public Safety Technician II. My duties have expanded to approving shift bids and annual leave requests, monitoring payroll and activity reports, conducting staff meetings, and completing evidence inspections at the Soldotna Post, Valdez Post, and the Cordova Post.

Prior to being promoted to Sergeant, I was a Wildlife Trooper stationed at the Soldotna Post duties associated with this position included but were not limited to; enforcement of Alaska Statutes and Regulations pertaining to public safety with an emphasis on the enforcement of commercial fishing, hunting, sport fishing, personal use fishing, and trapping laws on the Kenai Peninsula. As a result of this enforcement, I was required to: issue warnings, citations, criminal complaints, request warrants, and make physical arrests. I was also required to prepare written case reports and defend the prepared cases in Court. Additional duties include the utilization of ATV's, snow machines, boats, and four-wheel drive trucks as patrol units to investigate resource user activity for legal and illegal uses.

While assigned as an Alaska State Trooper, I have had the opportunity to work in "D" Detachment Fairbanks Post (2001-2003) and "C" Detachment Nome Post (2003-2007). The experiences and opportunities I received have provided me with a different and broader perspective than many individuals within our Department.

During my time as an Alaska State Trooper I investigated felony and misdemeanor crimes which have included but were not limited to; various degrees of Assaults, Sexual Assaults, Death Investigations, Motor Vehicle Collisions, and Driving Under the Influence crimes.

Additional duties included public appearances, courtroom testimony, search and rescues, VPSO Oversight, serving as a primary Field Training Officer, and being appointed as an Officer in Charge; often over senior Troopers.
