# Analysis

This bill expands the crimes of Assault in the 1<sup>st</sup> Degree, Sexual Assault in the 3<sup>rd</sup> Degree, and Sexual Abuse of a Minor in the 3<sup>rd</sup> Degree. Juveniles charged with offenses modified under the legislation will be referred to the Division of Juvenile Justice. The bill is not expected to have any fiscal or programmatic impact on the division.
