HOUSING ASSISTANCE  
FOOD STAMPS

IN ORDER TO RECEIVE OUR MONTHLY INCOMES LEGALLY.***

LEGISLATORS MAKING THESE ILLEGAL DEMANDS OF THEIR  
CONSTITUENTS ARE NOT RECIPIENTS OF THESE PROGRAMS.  
ASKING US TO BREAK LAWS IN ORDER TO HAVE PRESCRIPTIONS  
FILLED/REFILLED ANNUALLY IS EGREGIOUS.

RECIPIENTS ARE REQUIRED TO FULFILL EACH PROGRAM'S RULES  
AND REGULATIONS IN ORDER TO CONTINUE RECEIVING OUR  
\$1000.00 PER MONTH STIPENDS,  
WHICH, IN ALASKA'S CURRENT ECONOMY,

***FAILS MISERABLY***

**UNDER 7AAC 110.715: "MEDICAL NECESSITY IS COVERED"**

**I AGREE MEDICAID AND MEDICARE NEED CHANGES FOR  
THE BETTERMENT OF ALL CONCERNED, HOWEVER,**

**NO ONE...I REPEAT...NO ONE CAN VIOLATE LICENSED  
PRACTICING MEDICAL PHYSICIANS' PATIENT CARE  
ORDERS. MEDICAID EMPLOYEES AND LEGISLATORS ARE NOT  
LICENSED MEDICAL PROFESSIONALS, ERGO, LEGISLATORS  
AND MEDICAID'S LOWEST BIDDER CONTRACT EMPLOYEES  
ADJUDICATING MEDICAID CURRENTLY...DBA...CONDUENT ARE  
PRACTICING MEDICINE WITHOUT A LICENSE...A FELONY  
PUNISHABLE BY LAW.**

**FELONS CAN NOT HOLD/RUN FOR POLITICAL OFFICE...OR ENJOY  
THE PRIVILEGES AND RESPONSIBILITIES FREEDOM  
CARRIES. LEADERS, MUST AT ALL TIMES BE ABOVE REPROACH IN  
EVERY CHOICE YOU CHOOSE TO MAKE...AKA...#INTEGRITY.**

BEING ABLE TO WORK IS A PRIVILEGE. I WISH I STILL COULD!! YOU  
ARE RUBBING SALT INTO OUR WOUNDS WITH YOUR ILLEGAL  
DEMANDS FOR DISABLED MEDICAID RECIPIENTS TO WORK IN  
EXCHANGE FOR MEDICAL COVERAGE. CURRENTLY ALASKA'S  
MEDICAID PROGRAM IS ADJUDICATED BY THE LOWEST CONTRACT  
BIDDER. THIS POOR CHOICE HAS CLOSED MANY BUSINESSES  
STATEWIDE WHICH ACCEPTED MEDICAID PAYMENTS. CONDUENT IS  
THE CURRENT LOWEST BIDDER. PRIOR TO THAT XEROX, YES, THE

COPIER PEOPLE XEROX, WERE THE LOWEST BIDDER. NEITHER COMPANY HAS ANY EXPERIENCE IN THE MEDICAL PROFESSION. NEITHER ONE REQUIRES PROSPECTIVE EMPLOYEES HAVE THE SAME TRAINING AS THOSE IN MEDICAL PROVIDERS STATEWIDE. CONDUENT CHANGED IT'S RATES AND WITHHELD INFORMATION FROM ALL MEDICAL PROVIDERS FOR A YEAR! THEY FINALLY INFORMED EVERY PROVIDER IN THE STATE ACCOMPANIED BY A BILL FOR SEVERAL THOUSAND DOLLARS ASKING PRACTICING PHYSICIANS: "HOW WOULD YOU LIKE TO PAY THAT WITHIN 24 HOURS?"!!! POSSIBLY WHY THE ONLY ASSISTED LIVING HOME IN DELTA JUNCTION CLOSED IMMEDIATELY AND WITHOUT PROPER NOTICE? A TRAVESTY CONSIDERING IT HAD JUST OPENED.

MEDICAID DBA CONDUENT WASTED 4 YEARS OF MY LIFE ARGUING ABOUT A LEGITIMATE PRESCRIPTION REFILL FOR EYEGLASSES WHICH HAVE BEEN COVERED SINCE MY FIRST PAIR EVER OVER THE LAST 3 DECADES. UNQUALIFIED EMPLOYEES ARGUED WITH LICENSED MEDICAL PROFESSIONALS.

MY CASE WENT TO COURT & THROUGH A LENGTHY APPEAL PROCESS BEFORE JUDGE SIEBOLD REVERSED MULTIPLE DENIALS. IN ORDER TO PAY FOR MY EYEGLASSES I WAS FORCED TO GO WITHOUT FOOD FOR TWO YEARS! I WAS RELEGATED TO ONLY ONE MEAL EVERY OTHER DAY IN ORDER TO MAKE SMALL PAYMENTS MYSELF. THIS WAS FURTHER COMPOUNDED BY THE THEFT OF MY PFD THREE YEARS RUNNING. WE ARE STILL RESPONSIBLE TO PAY THE BILLS WHICH ARE STILL OUTSTANDING DUE TO ILLEGAL PFD THEFT. HOW DO YOU EXPECT YOUR CONSTITUENTS WHO ARE BELOW THE POVERTY LEVEL TO WITHSTAND SUCH AN ATTACK BY THE VERY PEOPLE WE HIRED TO WORK FOR US??! WE ARE STILL "OPERATING IN THE RED"!

CONDUENT EMPLOYEES ENDANGERED MY LIFE LIKE THEY DO DAILY WITH OTHER MEDICAID RECIPIENTS, WITH THEIR INSANITY. CONDUENT INCREASED MY MEDICAID OUTGO, REQUIRED ME TO SEE A SPECIALIST, PAID FOR DOUBLE HOTEL/CAB/MEAL VOUCHERS, IN ADDITION TO BEING THE ONLY REASON I WAS DIAGNOSED WITH AN ADDITIONAL MEDICAL MALFUNCTION MY MD. VERIFIED WAS SOLELY DUE TO PHYSICAL STRESS DUE TO CONDUENT'S ILLEGAL DENIAL OF 7AAC110.715 & LACK OF A TIMELY

EYEGASSES PRESCRIPTION REFILL. MEDICAID PAID MORE THAN  
DOUBLE THE PAIR OF EYEGASSES ANNUAL COST: \$600.00

WEARING OUTDATED PROGRESSIVE TRIFOCALS WITH  
TRANSITIONS LENSES WHICH ARE MEDICALLY REQUIRED IS  
DEADLY. THIS IS THE MOST EXPENSIVE MEDICAL NEED I HAVE  
ANNUALLY!! NO PERSON SHOULD BE REQUIRED TO STARVE FOR  
TWO YEARS DUE TO UNQUALIFIED MEDICAID CONTRACTOR'S  
EMPLOYEES...EVER!

OUR LEGISLATORS MUST REQUIRE MEDICAID EMPLOYEES  
ADJUDICATING FEDERAL FUNDS ON PATIENT'S BEHALVES HAVE  
IDENTICAL TRAINING REQUIRED BY MEDICAL PROVIDERS,  
HOSPITALS, CLINICS ET.AL..

FIBROMYALGIA? YOU HAVE HAD OVER 30 YEARS TO CREATE ONE!  
WHERE IS IT? IF A CURE WAS AVAILABLE...I WOULD HAVE THE  
ABILITY TO EARN A DECENT LIVING AGAIN!
