Just because marijuana is legal does not mean that it is in the states interests to forge ahead full bore with only industry interest in mind. This industry is going to have impacts on the communities and people surrounding it; including youth use, addiction, and drugged driving. There is no reason why public health and safety interests shouldn't also be represented on the MCB board. Why does the industry believe that only their interests are the ones that are relevant to consider?

Brandon Emmett is quoted as saying that concerns for teen consumption and drugged driving is spreading "misinformation". The fact is that nobody has definitive data yet to know what the impact of marijuana legalization will be in the long term and suggesting that they do, is misinformed.

Those of us who work in the addiction treatment field are well aware of the negative impact of chronic marijuana use. There is no reason to think that marijuana is any different than any other intoxicating substance; some high functioning affluent people can use the substance recreationally with no problems at all, while other people's lives and communities are completely devastated by it.

The marijuana industry is following a path well-trod by the previous addictive substance industries: tobacco, vape and opioids; claiming that their products are safe, harmless and NOT addictive. And that their product is going to cure you of whatever ails you: Alcohol and opioid addiction, violence and cancer.

I ask you, which is more likely to be misinformed? The claim that an intoxicating substance has the potential to be addicting and harmful, or that it is going to cure cancer?

Asking to consider the potential impacts of marijuana legalization on public health and safety, and to address prevention measures, does not make one a prohibitionist.

Kristin Cox, ND Rainforest Naturopathic Medicine I am writing to support Vivian Stiver's nomination to the Marijuana Control Board. I attended the Committee hearing by phone last Wednesday and frankly was surprised at the poor arguments against her, as put forth by the marijuana industry.

First, she was peppered with criticism for not being a marijuana user. If the industry thinks there is no room for someone who does not use marijuana on the Control Board, that is a revelation. Frankly, I want someone on the Control Board who does not use it, and is an advocate for the safety and well being of Alaskans who also do not use it. The industry's position on this is telling and specious.

Next, Vivian was accused of being a trojan horse who would sabotage the industry by her presence on the Control Board. No explanation was given for the reason the industry does not want some balance on the Control Board by giving those who do not use marijuana and are skeptical of its safe proliferation, especially when it is difficult to measure its effects on drivers such as alcohol is, some input on matters of concern to the Control Board. A healthy skepticism is useful when diving into the unknown. Surely the industry itself wants to promote health and safety with respect to the public's consumption of its products. At least it says it does. If that is true, someone who does not swallow information whole, without verifying its accuracy, would be an asset to the Control Board and industry.

Vivian was also accused of being a prohibitionist. I know this is not the case because in her work on the City of Fairbanks initiative, she specifically told me that medical marijuana was allowable. That is not a prohibitionist. At the time she clearly thought some uses were acceptable.

Consequently, I urge you to ignore the hysterics testifying against her and use common sense by confirming her. Vivian's fair-mindedness, good business sense, organizational skills, and work ethic would be an asset to the Control Board.
