- Services substance abuse treatment, mental health services, food and shelter for the low income, sexual assault shelters, domestic violence treatment, runaway shelters, health services for low-income, housing and rehabilitation for the physically and mentally ill
- Services are purchased through contracts with non-profit sub-grantee agencies.
