### STATE OF ALASKA 2018 LEGISLATIVE SESSION

# **Analysis**

This legislation would repeal the state aid for costs of school construction debt, also referred to as the School Debt Reimbursement Program. This legislation amends statute to remove references to AS 14.11.100 to bring affected statutes into conformity with the repeal of the debt reimbursement program. AS 14.11.014(a) and (b) are amended to change the name of the Bond Reimbursement and Grant Review committee to the Grant Review committee and to have the committee develop criteria for "consideration of multipurpose function and designs to reduce overall facility cost for the affected community." In addition, the calculation in AS 14.11.025, state aid for school construction in regional educational attendance areas and small municipal school districts, would be amended to use the currently approved annual debt service from AS 14.11.100 to calculate the budget amount for the fund.
The department would need to review regulations and make necessary changes to bring school construction regulations into conformity with the repeal of AS 14.11.100.
