## FISCAL NOTE ANALYSIS

## STATE OF ALASKA 2019 LEGISLATIVE SESSION

#### BILL NO. SB 79

#### Analysis

There are several components throughout this bill. This bill supports virtual education and requires the Department of Education and Early Development to establish a virtual education consortium (AS 14.30.760) with cooperation of school districts. The bill amends AS 14.03.073 by outlining a process for school districts to provide opportunities for students to challenge courses for credit using a district determined assessment tool to ensure mastery of the material, as well as provides opportunities for students to earn credit outside of the school day in the areas of career and technical, art, music, physical and cultural education. This bill amends AS 14.03.078 by changing the department's February 15 report to the legislature to include school districts, as well as requiring the department to compare from October 1 the previous year, the ratio of administrative employees to students in each district. School districts would also be required to post this information on their website. In addition, this bill amends AS 14.17.505 by increasing the limit that a school district is allowed to retain in its unreserved fund balance from 10% to 25% of district expenditures. This bill amends AS 14.20.020 by requiring the department to provide administrative support services to the Professional Teaching Practices Commission (PTPC).

The legislative findings related to virtual education and changes to AS 14.03.073 take effect July 1, 2020; the remaining sections in the bill take effect immediately under AS 01.10.070(c).

The fiscal impact to the department under this bill is in regards to AS 14.30.760, Virtual education consortium. This portion of the bill requires the department to do the following:

1) establish a virtual education consortium (1 PFT position);

2) review curriculum and approve courses (3 PFT positions - content specialists in Language Arts, Mathematics, and Science; and 1 PFT Education Associate II);

3) provide virtual instruction methods for teachers of grades six through 12 (same as #2);

4) professional development courses for teachers of any grade (same as #2);

5) create and maintain a database of all virtual courses and professional development created (2 PFT positions); and

6) ensure teachers have completed training in virtual education or demonstrate that they have experience teaching virtual courses (same as #1).

A total of 7 PFT positions are necessary to enact this legislation. (6 - Education Specialist II, Range 21, Step B, at \$119.4 each = \$716.4 and 1 - Education Associate II, Range 15, Step B, at \$90.0). Total associated costs for these 7 positions includes salary and benefits of \$806.4 and department chargebacks of \$67.2 (\$9.6 per position).
