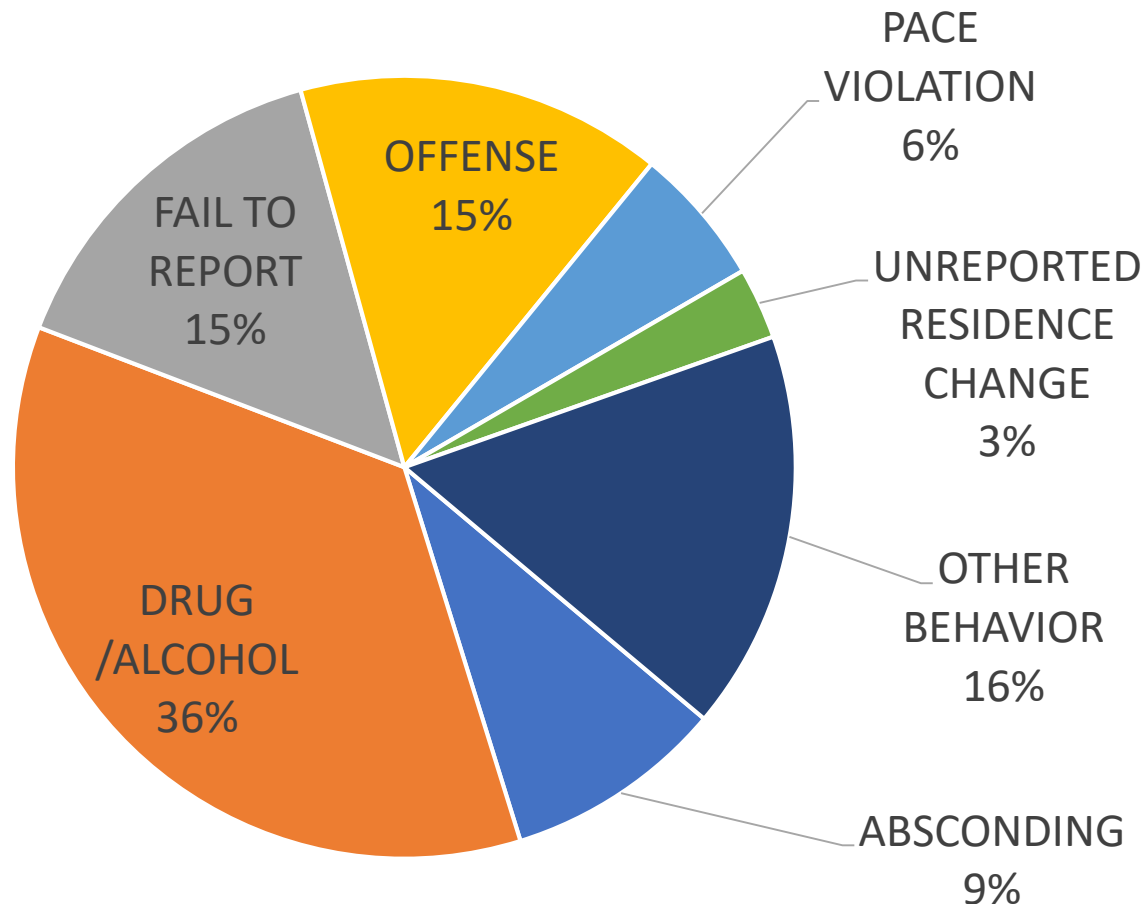

# EARNED COMPLIANCE CREDIT (ECC)

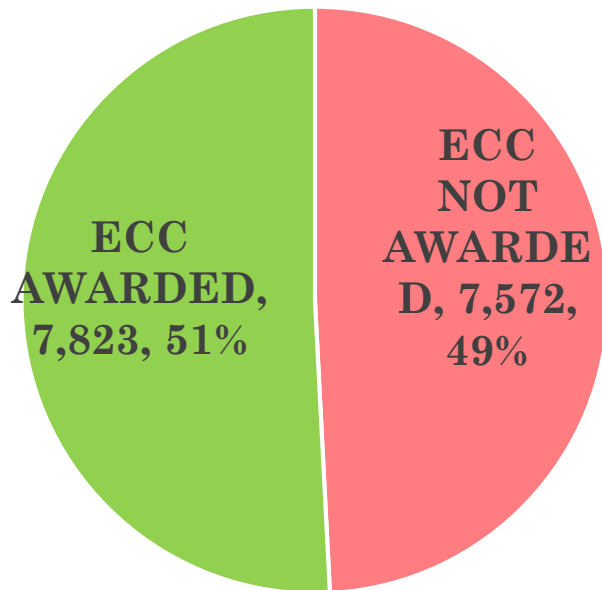
- For every month of positive behavior while on Probation/Parole, 30 days are deducted from supervision.
- Once awarded, it remains even if subsequent undesired behavior.
