# **Analysis**

This Bill sets in statute the current FY2019 Alaska Pioneer Home rates, which are reflective of less than half the costs of providing pioneer home services. Under this legislation, the State will continue to subsidize the cost of services to all residents, including those with private pay ability.
The fiscal notes submitted reflect a reversal of the proposed FY2020 Governor's Amended budget changes that were to enact a rate increase and establish a separate Alaska Pioneer Homes Payment Assistance budgetary component.
