FISCAL NOTE ANALYSIS

STATE OF ALASKA 2019 LEGISLATIVE SESSION

BILL NO. SB 90

Analysis

Secs. 1 – 4. Because these sections do not apply to Department of Natural Resources (DNR), the department does not anticipate any fiscal impact from these sections.

Sec. 5. Revises AS 16.43 to add a new section AS 16.43.332 to create an elective Alaska Department of Fish & Game (ADF&G) commercial shore setnet entry permit buy-back program. The proposed buy-back program would allow ADF&G to repurchase up to 200 limited entry fishing permits, and requires DNR to terminate without penalty or charge the corresponding shore fish land leases.

Currently, annual rental rates for these shore fish land leases is \$300 per lease. Loss of up to 200 shore fish land leases would reduce revenues to DNR up to \$60,000 annually. However, DNR manages the state's shore fish land lease program from annual rentals from shore fish land leases. Accordingly, under AS 38.05.082, DNR would offset any revenue reduction by increasing the annual rental rate on all remaining shore fish land leases. DNR anticipates that the effort to terminate the affected leases under the bill will not require any additional funding.

This section also requires ADF&G to provide DNR with notice of the sale, the seller's identity, and the affected lease under AS 38.05.082, when ADF&G purchases an ADF&G entry permit under this program. In return, DNR is required to provide ADF&G with the geographic and legal boundaries of a tract for which lease is cancelled under this section. DNR anticipates that the effort to share lease data regarding the affected leases under the bill will not require any additional funding.

The bill is unclear whether the fishery closure anticipated in this legislation applies only to ADF&G's limited entry permits program or to DNR's management of state lands and the issuance of shore fish land leases. For the purposes of this fiscal note, DNR assumes that the limitations only apply to ADF&G's commercial shore setnet entry permits, and that any fishery limitations will be manifested through ADF&G's opening or closing of areas in Eastern Cook Inlet. DNR assumes that these limitations do not apply to DNR's management of state land and that DNR will not be required to maintain shore fish land lease closures indefinitely. Lastly, DNR assumes it will be allowed to continue to issue shore fish land leases to those with a commercial shore set net entry permit in the future if the area is still open to commercial setnet fishing.

Secs. 6 – 8. Based on the assumptions in section 5, DNR does not anticipate any fiscal impact from these sections.
